



‘DFY’ YT AUTOMATION GUARANTEE OUTLINE

NOTICE: THIS GUARANTEE APPLIES TO THE DFY \$60,000 PACKAGE ONLY. FOR THE \$25,000 PACKAGE, PLEASE SEE THE TERMS RELATED TO THE [DFY ELITE PACKAGE](#). FOR THE [DWY \\$12,000](#) PACKAGE, PLEASE SEE ITS TERMS & CONDITIONS.

SERVICES OUTLINED:

➤ Ownership of 1 "Viral Style" YouTube Channel (referred to as the "Channel")
➤ A content span of 24 Months, commencing from the date of the first video posted after the Agreement's full execution (termed the "Channel Start Date").

- Regular posting of 8-12 videos each month
- Artistic Design
- Research
- Script Creation
- Voiceover Services
- Video Editing
- Video Production
- Channel Management

The Service Provider commits to offering these services (collectively referred to as the "Channel Content and Management Services") for a duration of 24 Months (dubbed the "Initial Content Package").

The Client acknowledges that the ongoing growth and revenue generation of the Channel rely on consistent video production and uploads. A minimum of 8 videos and a maximum of 12 videos must be produced and managed monthly. The optimal quantity of uploads may vary, considering YouTube's algorithmic responsiveness. Hence, the monthly video production and management range is set at 8 to 12 videos.

Continual management will persist as long as the Service Provider produces content for the Channel. This Agreement does not anticipate a perpetual, indefinite relationship. The Service Provider's assignment of services to the Client is restricted to the terms defined in this Agreement, yet the parties may mutually agree on terms outside the scope of this document.

The Client acknowledges that Channel success may require a time span of 6 months or longer. The Service Provider has no influence over potential earnings or the pace of results. The Service Provider commits to granting full access and complete transparency of the Channel to the Client. The Service Provider undertakes to employ all efforts to optimize the Channel's potential for success. In case the Buyer's Channel loses monetization, a new Channel will be established at the Service Provider's expense.

PAYMENT FOR SERVICES:

Commencing with the Agreement's execution, the Client agrees to the following financial commitments: • \$60,000 USD ("Initial Investment"), with \$60,000 payable upon the Agreement's execution, covering 24 Months of video content and channel management for 1 Channel, where months 13-24 receive a subsidy from the Service Provider.

CLIENT COMPENSATION:

- Clients compensation will be 100% Of Revenue Generated by their YouTube Channel for the first 12 months Or 18 Months if the income of the channel does not reach the full amount of \$60,000.
- If 12 months have past and the Client has made 100% return on their investment, and the Client's Channel generates revenue exceeding \$0 within 14 days following the end of each month, the Licensor will do a 70/30 profit split with 70% to client and 30% to the company from channel profit after expenses.

The Client will receive 70% of Net Profit generated through the Channel's Revenue Streams, which encompass Google Adsense, brand sponsorships, affiliates, and advertising deals. The Client will be compensated until the initial \$60,000 investment is fully recovered.

Google Adsense typically disburses earnings monthly, between the 20th to 25th of each month, for the preceding month's income. Google Adsense enforces a minimum withdrawal threshold of \$100. The Service Provider will offer guidance and assistance, if needed, to establish linked accounts. The Client is accountable for reporting all revenues and handling tax responsibilities related to the Channel, whether personal or business-related.

AD ACCOUNT:

Within 60 days of Channel connection, the Client commits to linking and verifying their Google Adsense account (termed the "Initial Connection Period"). The Service Provider will offer reasonable support for timely completion of this process. Channel revenue relies on Google Adsense linkage; thus, the Client acknowledges that failure to exert due effort during the Initial Connection Period will result in a theoretical \$1,000 deduction per month past this period, set against revenue generated for the Buy Back Guarantee.

FORCE MAJEURE:

Performance under this Agreement may be disrupted by causes beyond either party's control ("Force Majeure"). Such events will suspend the affected party's obligations to the extent necessary. Reasonable efforts will be taken to avoid or mitigate causes of non-performance.

GUARANTEE:

The Client benefits from a Buy Back Guarantee (referred to as the "Buy Back Guarantee") under certain stipulations. If by day 730 (or 1st day of your channel's third year), and the Channel fails to generate at least \$2,500/mo. and/or \$60,000 in total revenue across its revenue streams over the course of 24mo (whichever comes first), the Client has two options:

- We will continue to work with you on your channel until you have reached your initial investment.
- We will purchase the channel back at its original buildout fee less the channel's entire profits.

The Buy Back Guarantee applies only if the Client remains engaged with the Service Provider for a continuous 24-month period.

CONFIDENTIALITY:

The Client may access proprietary and confidential information, agreeing not to misuse it to tarnish the Service Provider's reputation or mislead others regarding YouTube. Both parties agree not to breach this Agreement during or after its term.

RELATIONSHIP OF PARTIES:

Both parties acknowledge their independent status and mutually agree that they are not each other's employees. Each party is responsible for its employees' benefits.

DISPUTE RESOLUTION:

Parties will first attempt amicable resolution, resorting to Alternative Dispute Resolution (ADR) if negotiations fail.

TERMINATION FORM:

The Consumer's Right to Cancel is only satisfied upon receipt of the following Cancellation Form deliverable to Faceless Freedom LLC 1317 Edgewater Dr #3828 Orlando, FL 32804 USA. In the event the consumer fails to comply with Faceless Freedom LLC's cancellation guidelines, Faceless Freedom LLC reserves the right to enforce any and all obligations agreed upon between itself and all parties herein this agreement. The Consumer may also request Cancellation at any time during the Consumer's Contract Term in the event a doctor's order pardon's this party due to his or her inability to physically receive services. This pardon will be in exchange for the Servicer's intent to revoke any and all future obligations whether financial or moral without the possibility of a refund.
