The Board of Supervisors of Overfield Township, Wyoming County, Pa., met at 7:00 P.M. on Monday, January 5, 2026 at the Overfield Township Municipal Building for the reorganization of Overfield Township Supervisors for the fiscal year 2026.

Those present were Donald Ames; John Walsh; John Manglaviti; and Susan Smith.

Mr. Ames opened the meeting with a call for the 'Pledge of Allegiance'. Susan Smith acted as temporary chairman until the election of chairman for 2026 was completed. Ms. Smith asked for a nomination for chairman of the Board. Mr. Manglaviti made a motion that Donald Ames be the chairman. Mr. Walsh seconded the motion. All in favor. So Carried. A motion was made by Mr. Ames that Mr. Manglaviti be the vice-chairman. Mr. Walsh seconded the motion. All in favor. So Carried.

Mr. Ames made the motion for the following: John Walsh be made Roadmaster; Susan Smith be made Sec./Treas.; Christine Shook/Lora Seidel-backup secretary; vacancy Board Chairman- Art Carpenter Jr. ; Robert Sheils - Township Solicitor; SEO-KBA; Barry Isett-Engineering; Planning Commission is to consist of Guy Tench, Bert Occulto, Jason Lewis, Matt Toolan and Art Carpenter Jr.; Cody Stanco appointed as zoning officer; Zoning Hearing appointments - Paula Schloder (2 years); Joe Oliver (1 year), Mike Cupinski (3 years), David Kennedy-Alternate; Cody Stanco - floodplain officer; Robert D. Barber -LWMA 2026 appointee; Susan Smith to be the open records officer and the Act 32 (TCC) officer; Cody Stanco- EMA coordinator; Ginader & Jones-CPA; Bureau Veritas -3rd party inspection service; Park Committee-Paula Schloder, Christine Sheehan, Teri Ace-Lehnert; Board of Appeals-Marty Bonifanti, Mike Bouselli; pay officials attending sessions and/or schools to enhance, expand, or improve performance of their duties with the approval of the supervisors registration paid by officials with mileage at IRS set rate per mile; the Supervisors/Secretary to attend the State and or National Convention and to be paid according to their prevailing wage and Sec/Treas Susan Smith to be the voting delegate. The Supervisors are to hold 1 meeting/month and meetings to be on the second Tuesday of the month (7:00-9:00 PM maximum) and that citizen participation be limited to three (3) minutes/person per subject discussed during Township meetings as stated in policy, that the First National Bank be the depository for Overfield Township and PLGIT also be used for automatic EIT deposit and savings; and pay temporary laborers, truck drivers, and equipment operator's \$14/hr.; Mr. Manglaviti seconded the motion. All in favor. So carried. Mr. Manglaviti made a motion for the following: a 3% increase for workers; paid holidays, comp time, bereavement time as set in policies; Paid vacation (2 week after 1 year, 3 weeks after 4 years, 4 weeks after 8 years and 5 weeks after 20

years of employment); paid sick time of 1 week/year after 1 year of employment; paid accident insurance after 90 days. Mr. Walsh seconded the motion. All in favor. Motion carried. Mr. Ames made a motion that Supervisors can work on the road crew and John Walsh is to be a full-time employee Monday-Fri 6:30 AM to 2:30 PM. Mr. Manglaviti seconded the motion. All in favor. So Carried.

With no further reorganization business brought before the Board, Mr. Ames made a motion to adjourn. Mr. Manglaviti seconded the motion. All in Favor. Meeting adjourned at 7:05 PM.
