The Board of Supervisors of Overfield Township, Wyoming County, Pa., met at 7:00 P.M at the Overfield Township Municipal Building for their eighth regular meeting for the fiscal year 2025.

Those present were; Chairman-Donald Ames; Vice Chairman-John Manglaviti; Roadmaster- John Walsh; Zoning Officer- Cody Stanco and Sec. / Treas. - Susan Smith and 2 residents.

The minutes of the July 8th meeting were not read as copies were e-mailed to all supervisors prior to the meeting. Mr. Walsh made a motion that the minutes be accepted as written. Mr. Manglaviti seconded the motion. All in favor. Motion carried.

Zoning report

Cody Stanco gave the Zoning report for July. There were 7 permits issued; no certificates of nonconformance; the Zoning Hearing Board gave variance for 0 Frear Lane; Zoning Hearing for 278 Point Road scheduled for 8/21/25 and 2 enforcement notices sent. Mr. Manglaviti made a motion to accept the Zoning report. Mr. Walsh seconded the motion. All in favor. Motion carried.

Road Report:

Mr. Walsh gave a summary of the road work done in July: brush cutting; assisted Tunkhannock, Lemon Township, Springville Township and Washington Township; calcium was put down and the Freeman Road project has been completed. A motion was made by Mr. Ames to accept the road report. Mr. Manglaviti seconded the motion. All in favor. Motion carried. Resolution 2025-0812 was presented for the Winter Agility Contract (see winter agility file). Mr. Manglaviti made a motion to pass Resolution 2025-0812. Mr. Walsh seconded the motion. All in favor. Motion carried.

Police Report

Susan Smith gave the police report for July: There were 27 incidents: 3 traffic citations, 0 traffic warnings, 1 criminal arrest (1 charge), 6 hours vascar, 40 hours patrol and 30 hours for incidents. A motion was made by Mr. Ames to accept the police report. Mr. Manglaviti seconded the motion. All in favor. Motion carried.

New Business

- Clean up- After some discussion it was decided to forgo clean up this year due to the lack of participants last year and to revisit the subject next year and possibly schedule clean ups every other year.
- Windward Lane- Mr. Walsh made a motion to accept the agreement with the residents of Windward Lane to plow Windward Lane for safety reasons for the drivers. Mr. Manglaviti seconded the motion. All in favor. Motion carried.
