The Board of Supervisors of Overfield Township, Wyoming County, Pa., met at 7:00 P.M. at the Overfield Township Municipal Building for their third regular meeting for the fiscal year 2022.

Those present were; Supervisor-John Manglaviti; Roadmaster- John Walsh; Sec. / Treas. - Susan Smith; Zoning Officer-Chad Patton; Police Chief-Ed Morristell; CPA-Eric Davis and 1 signed in resident. Chairman-Donald Ames was absent.

The first order of business was the awarding of bids on municibid as advertised. The high bidders were as follows:

- Rake- \$410.00 to Matt Russell- A motion was made by Mr. Manglaviti to award the bid for \$410. Mr. Walsh seconded and the motion passed.
- Spreader- \$650.00 to Jonathan Peters- Mr. Manglaviti made a motion that was seconded by Mr. Walsh to award the bid for \$650.00 and the motion passed.
- Leaf Vac-\$10,450.00 to Kane Frentzel- A motion was made by Mr. Manglaviti and seconded by Mr. Walsh to award the bid for \$10,450.00 and the motion passed.

- -A motion was made by Mr. Manglaviti and seconded by Mr. Walsh to bid for full depth reclamation of Orchard Drive. All in favor and the motion passed.
- -A motion was made by Mr. Manglaviti and seconded by Mr. Walsh to have a spring road inspection on March 23rd at 9:00AM. All in favor. Motion carried.

Audience Participation:

- -Resident Ron Thomas asked about the potholes on Church Road. Mr. Walsh stated that he repaired the road with cold patch today. Mr. Walsh also stated that he was working on getting a grant to repair Marina, Post Office and Church Road.
- -CPA Eric Davis asked about Orchard Drive being turned back to dirt and was told that there was no base to the road when it was paved.

With no further business brought before the Board, Mr. Walsh made a motion to adjourn. Mr. Manglaviti seconded and the motion carried. Meeting adjourned at 7:37.
