The Board of Supervisors of Overfield Township, Wyoming County, Pa., met at 7:00 P.M at the Overfield Township Municipal Building for their ninth regular meeting for the fiscal year 2025.

Those present were; Chairman-Donald Ames; Vice Chairman-John Manglaviti; Roadmaster- John Walsh; Zoning Officer- Cody Stanco; Sec. / Treas. - Susan Smith; Chief Ed Morrisstell; Fire Company Representatives -Roy Landsiedel, Bob Hug and Gene Dziak and 3 residents.

The minutes of the August 12<sup>th</sup> meeting were not read as copies were e-mailed to all supervisors prior to the meeting. Mr. Walsh made a motion that the minutes be accepted as written. Mr. Manglaviti seconded the motion. All in favor. Motion carried.

**Zoning report**

Cody Stanco gave the Zoning report for August. There were 4 permits issued; 1 certificates of nonconformance; the Zoning Hearing Board gave variance for 278 Point Road on 8/21/25 and 2 enforcement notices were sent. Mr. Manglaviti made a motion to accept the Zoning report. Mr. Walsh seconded the motion. All in favor. Motion carried.

**Road Report:**

Mr. Walsh gave a summary of the road work done in August: brush cutting; worked with Tunkhannock, Lemon Township, Springville Township and Washington Township; Freeman Road project has been completed; Dolph Lane work has started. A motion was made by Mr. Ames to accept the road report. Mr. Manglaviti seconded the motion. All in favor. Motion carried.

**Police Report**

Chief Morrisstell gave the police report for August: There were 25 incidents: 8 traffic citations, 0 traffic warnings, 0 criminal arrest, 8 hours vascar, 40 hours patrol and

30 hours for incidents. A motion was made by Mr. Walsh to accept the police report. Mr. Ames seconded the motion. All in favor. Motion carried.

#### **Park Committee Report**

Paula Schloder and Terri Ace-Lehnert gave the park committee report: there will be a 2:00- 4:00 Halloween Trail hike for the kids on October 18<sup>th</sup>, Candy donations are needed, prayer walks will start Sunday at 12:15, gravel will need to be spread before October 18<sup>th</sup>, and volunteers are needed to pass out candy. Mr. Walsh made a motion to accept the Park Committee report. Mr. Manglaviti seconded the motion. All in favor Motion carried.

#### **Unfinished Business**

-New Truck financing- Quotes for the truck uplift were reviewed. Estimates were from Tamaqua Truck and Lowe's. (see 'Sherwood 2026 Frtl' file). A motion was made by Mr. Manglaviti to purchase the uplift from Lowes Sales & Service for the costar price of \$85,000 Mr. Ames seconded the motion. All in favor. Motion carried.

-Solicitation Ordinance- After some discussion Chief Morristell agreed to provide his assistance with some questions.

#### **New Business**

-Resolution 2025-0909- a correction of Resolution 2025-0708- Hazard Mitigation. Mr. Walsh made a motion to pass Resolution 2025-0909. Mr. Manglaviti seconded the motion. All in favor. Motion carried.

-Comcast-Information package was given to the Supervisors to review regarding holding the franchise for Comcast in the Township.

-Fire Company tax increase- Roy Landsiedel, Gene Dziak and Bob Hug represented the Lake Winola Fire Company. Roy stated that the fire company is looking for a tax increase from .4 mills to 1 mill since insurance is not even covered by the .4 mills collected. Gene stated that the vehicles are presently in good condition and their focus is on equipment which is being tested presently for its ability to be used. Prices for nozzles and hoses were given as examples. Bob and Gene stated that there are grants being applied for to offset the rising costs of tools and equipment. There was some discussion regarding fund raising and grant applications. Mr. Ames stated that the board would meet in executive session and that they would have an answer at the October meeting.

#### **Audience Participation:**

-Dave Kennedy inquired about Paul Barteletti's property on the lake being cleaned up. No one had an answer if anything other than cleaning was being done.

With no further business brought before the board, Mr. Walsh made a motion to adjourn. Mr. Manglaviti seconded the motion. All in favor. So Carried. Meeting adjourned at 7:37 PM.
