The Board of Supervisors of Overfield Township, Wyoming County, Pa., met at 7:00 P.M. at the Overfield Township Municipal Building for their eighth regular meeting for the fiscal year 2024.

Those present were; Chairman-Donald Ames; Roadmaster- John Walsh; Sec. / Treas. - Susan Smith; Zoning Officer-Chad Patton; Wyoming County DA-Joe Peters and 8 signed-in residents. Supervisor- John Manglaviti was absent.

Wyoming County District Attorney, Joe Peters, addressed the audience. Mr. Peters stated that he was going to all the townships and boroughs to talk about Narcan and to distribute it at each building. Mr. Peters explained how the use of Narcan (nasal spray) will save the life of someone who has overdosed on an opiate drug. Mr. Peters stressed that drug overdoses take place with people of all ages, genders and social status. His program is to spread awareness and distribute the Narcan in the hopes that lives may be saved.
