The Board of Supervisors of Overfield Township, Wyoming County, PA., met at 7:00 P.M. at the Overfield Township Municipal Building for their fourth regular meeting for the fiscal year 2021.

Those present were: Chairman-Donald Ames; Supervisor-John Manglaviti; Roadmaster-John Walsh; Sec./Treas.-Susan Smith; Zoning Officer-Chad Patton; Tunkhannock Police Chief-Ed Morristell and 1 signed in resident.

The first item of business was the opening of bids. The bids for paving were opened as advertised. The bids read as follows:

-H & K Group- \$132,062.73  
-New Enterprise Stone & Lime Co- \$178,239.00

After some discussion, a motion was made by Mr. Walsh and seconded by Mr. Manglaviti to accept the bid from H & K Group for \$132,062.73. All in favor. Motion carried.

In order to save time so that Chief Morristell could return to duty, New Business was brought up before township reports. A motion was made by Mr. Manglaviti to have Attorney Litwin represent the township in making an agreement with Tunkhannock Township regarding police protection. This motion was seconded by Mr. Walsh and the motion carried. A motion was made by Mr. Ames and seconded by Mr. Manglaviti to have Paul Litwin follow through with the preparation of the Police Agreement and the Ordinance. All in favor. Motion carried. Mr. Ames made a motion to appoint Mr. Manglaviti as Police Commissioner. Mr. Walsh seconded the motion. All in favor. Motion carried.

The minutes of the last meeting were not read but copies were e-mailed to the Supervisors. A motion was made by Mr. Ames and seconded by Mr. Walsh to approve the minutes of the March 9<sup>th</sup> meeting. All in favor. Motion carried.

A motion was made by Mr. Walsh and seconded by Mr. Ames to accept the Treasurer's report. All in favor. Motion carried.

The bills were presented for review and discussion. A motion was made by Mr. Manglaviti and seconded by Mr. Walsh that the bills be paid. All in favor and the motion passed.

#### **Solicitor's Report- none**

#### **Planning Commission Report**

Chad Patton read the minutes from the Planning Commission meeting held in March. Mr. Manglaviti made a motion that was seconded by Mr. Walsh to accept the minutes. All in favor. Motion carried.

#### **Zoning Report**

Chad Patton gave the zoning report for March. There were 3 permits issued in March. Mr. Ames made a motion to accept the zoning report that was seconded by Mr. Walsh and the motion passed.

### **Road Report**

Mr. Walsh read a summary of the road work done in March which included grading and calcium on Fox road; ditches cleaned on Fox Road, Purdy and Freeman Road; potholes filled with cold patch on Point Road, Church Road and Orchard Drive; scrap taken to recycling center; shop clean up; maintenance on tractor; removing beaver dam on Erhardt Road; and placing signs. A motion was made by Mr. Manglaviti and seconded by Mr. Ames to accept the road report. All in favor. Motion carried.

### **Correspondence**

-DEP-Butts- Permit applied for dock. Permit 102 and 105. Chad Patton has been in contact with Neil from DEP regarding the permit. The permit has not been granted or rejected yet.

### **Unfinished Business**

-Summer hire- Mr. Ames made a motion to hire Luke Carpenter as a summer roadworker at \$14/hour. Mr. Walsh seconded the motion and the motion passed. Luke will start as soon as school lets out for the year.

-Chad Patton stated that the Galdieri Zoning Hearing was scheduled for May 17<sup>th</sup> at 6 PM at the township building. Chad also stated that there was a variance being heard by the Zoning Hearing Board on May 20<sup>th</sup> at 6 PM also at the township building for Burgess.

-Chad stated that he had visited the half-way house on Mislevy Road and asked the Supervisors how far they wanted him to go in resolving this matter. Chad was advised to call Attorney Litwin.

### **Audience Participation**

-Dave Kennedy wanted to tell the Supervisors that they were doing a great job working together.

With no further business brought before the Board, Mr. Walsh made a motion to adjourn. Mr. Manglaviti seconded the motion. The meeting was adjourned at 7:41 PM.
