The Board of Supervisors of Overfield Township, Wyoming County, Pa., met at 7:00 P.M. at the Overfield Township Municipal Building for their eighth regular meeting for the fiscal year 2022.

Those present were; Chairman-Donald Ames; Supervisor- John Manglaviti; Roadmaster- John Walsh; Sec. / Treas. - Susan Smith; Zoning Officer-Chad Patton; Dave Kennedy and Park Committee members-Peggy Leonhart and Paula Schloder.

The minutes of the regular meeting of July 12, 2022 were not read but copies were e-mailed to all supervisors prior to the meeting. Mr. Walsh made a motion that the minutes be accepted as written. Mr. Manglaviti seconded and the motion passed

**Police Report**

Susan Smith read the police report for the month of July. There were 49 calls, 2 traffic citations, no traffic warnings, no criminal arrest, 4 hours of vascar, 58 hours of patrol and 47 hours on incidents for the month. A motion to accept the report was made by Mr. Ames and seconded by Mr. Manglaviti. All in favor. Motion carried.

**Zoning report:**

Chad Patton gave the zoning report for July. There was 1 permit for the month for a new home. A motion was made by Mr. Manglaviti to accept the zoning report. The motion was seconded by Mr. Walsh and the motion passed.

**Road Report**

Mr. Walsh gave a summary of the road work done in July which included: completing oiling of roads, fence erected at building, brush mowing, weed whacking, work at Park including grading the parking lot. The Orchard Drive Project is scheduled for the August 17<sup>th</sup> and Marina Lane is scheduled for the August 22<sup>nd</sup>. Both dates are weather permitting. Mr. Ames made a motion to accept the road report. Mr. Manglaviti seconded the motion and the motion carried.

**Park Committee Report:**

Paula Schloder gave the report: planting of more perennials, 2 trees have been downed by wind and it will cost \$500 to move them so people are safe. LWMC has selected the Park to be the recipient of their fundraiser which will be held on August 27<sup>th</sup> from 4:00 – 6:30. The meal will be pork and pierogies. All are encouraged to come and to spread the word to others. A motion was made by Mr. Walsh and seconded by John Manglaviti to accept the Park Report.

- County Aid- The Conty Aid available for Overfield Township is \$2,372.08 and will be applied towards the Radar Sign purchased for use in Overfield Township.
- Winter Maintenance Agreement – A motion was made by Mr. Manglaviti and seconded by Mr. Walsh that the agreement for the 2022-23 season be accepted. All in favor. Motion carried. (\$4,195.29 for 3.31 miles)
- Windward Lane- The agreement to plow has not been received but should be submitted to the Board at the next Township meeting.
