The Board of Supervisors of Overfield Township, Wyoming County, Pa., met at 7:00 P.M. at the Overfield Township Municipal Building for their sixth regular meeting for the fiscal year 2023.

Those present were; Chairman-Donald Ames; Supervisor- John Manglaviti; Roadmaster- John Walsh; Sec. / Treas. - Susan Smith; Zoning Officer-Chad Patton; Park Committee -Paula Schloder and Terri Ace-Lehnert and 3 signed in resident.

The minutes of the regular meeting of May 9, 2023 were not read but copies were e-mailed to all supervisors prior to the meeting. Mr. Ames made a motion that the minutes be accepted as written. Mr. Manglaviti seconded and the motion passed

A motion was made by Mr. Walsh to accept the Treasurer's report. Mr. Ames seconded the motion and the motion passed.

The bills were presented for review and discussion. A motion was made by Mr. Walsh that the bills be paid. This motion was seconded by Mr. Manglaviti. All in favor. Motion carried.

**Planning Commission report:**

Chad Patton read the minutes from the May 2023 Planning Commission meetings. Mr. Ames made a motion to accept the report and Mr. Walsh seconded and the motion passed.

**Zoning report:**

Chad Patton gave the zoning report for May. There were 4 permits for the month. A motion was made by Mr. Manglaviti to accept the zoning report. The motion was seconded by Mr. Ames and the motion passed.

**Road Report**

Mr. Walsh gave a summary of the road work done in May which included: grading and dust control end to end on roads. Mowing is being done as is work at the park. A motion was made by Mr. Manglaviti to accept the report. Mr. Ames seconded the motion and the motion carried.

**Police Report**

Chief Morristell gave the police report for the month of May. There were 39 calls, 2 traffic citations, 1 warning, 3 hours of vascar and 52 hours of patrol for the month. There were 2 individuals arrested with 6 charges, 3 of them are felonies. There were 30 hours spent on incidents. A motion to accept the report was made by Mr. Ames and seconded by Mr. Manglaviti. All in favor. Motion carried.

**Park Committee Report:**

Paula Schloder gave the Park Committee report: The grant was awarded for \$5000. A cleanup was held May 23<sup>rd</sup> and 15 volunteers came to work. Terri stated that Triton Tree Service

came and cut down trees free of charge, The path was widened. They will be looking into the cost of a pickleball court and possible playground equipment. There is temporary paint on the basketball court for pickleball that will wash off. There is a resident that will donate paint for the dugout if needed since she has paint she hasn't used. A motion was made by Mr. Walsh and seconded by Mr. Ames to accept the report. All in favor. Motion carried.

#### **Correspondence**

-Wyoming County Association of Township Officials- Asking for \$500 donation. The request was reviewed in November and again by a letter and invoice. No action taken (no donation given). Dave McGovern Memorial Wiggle to be held on June 24<sup>th</sup>. Secretary has acknowledged the letter sent and had spoken with Roy Landsiedel. Chief Morristell was made aware of the event.

-County Aid- A motion was made by Mr. Walsh and seconded by Mr. Manglaviti to give the Treasurer permission to offset a general expense with the \$2,268.12. All in favor. Motion Carried.

-Truck Body- A motion was made by Mr. Manglaviti and seconded by Mr. Walsh to award the job to John Bonham. All in favor. Motion passed.

-Zoning Ordinance Changes- A copy of the proposed changes from Carson Helfrich were given to the Supervisors for review.

#### **Audience Participation:**

Cindy and Tom Coleman had concerns about the Blue Pelican and the health risks it presented. They stated that there was access inside the building and there are kids in the neighborhood that are hanging around there. They also stated that it was a health issue since rats have been seen there. Chad Patton stated that he has talked to Mr. Russo and that he (Russo) has promised to make it and to keep it presentable. Mr. Russo shared his desire to make the building a pizza shop. There was some discussion regarding the possible legislation that will help communities combat blighted property.

With no further business brought before the Board, Mr. Walsh made a motion to adjourn. Mr. Manglaviti seconded and the motion carried. Meeting adjourned at 7:45
