The Board of Supervisors of Overfield Township, Wyoming County, Pa., met at 7:00 P.M. at the Overfield Township Municipal Building for their third regular meeting for the fiscal year 2021.

Those present were; Chairman-Donald Ames; Supervisor-John Manglaviti; Roadmaster- John Walsh; Sec. / Treas. - Susan Smith; Zoning Officer-Chad Patton and 11 signed in residents and interested parties.

The first order of business was the opening of AEP bids as advertised. The bids read as follows for 20,000 more or less gals AEP:

Mr. Manglaviti made a motion that was seconded by Mr. Walsh to accept the lowest bid of \$1.65/gal from Suit-Kote. All in favor. Motion carried.

The minutes of the regular meeting of February 9th were not read but copies were e-mailed to all supervisors prior to the meeting. Mr. Ames made a motion that the minutes be accepted as written. Mr. Manglaviti seconded and the motion passed

A motion was made by Mr. Walsh to accept the Treasurer's report. Mr.

Manglaviti seconded the motion and the motion passed. Mr. Ames read a summary of the 2020 audit report in Eric Davis's absence. (see file)

The bills were presented for review and discussion. A motion was made by Mr. Ames that the bills be paid. This motion was seconded by Mr. Manglaviti. All in favor. Motion carried.

Solicitor's report: None Planning Commission report:

Chad Patton read the minutes from the February Planning Commission meeting. Mr. Manglaviti made a motion to accept the minutes and the motion was seconded by Mr. Walsh. All in favor. Motion carried.

Zoning report:

Mr. Patton gave the zoning report. There was one building permit.

Road Report

Mr. Walsh read a summary of the road work done in February which included filling potholes on dirt roads and with cold patch on paved roads, work completed on rooms in the building, shop cleanup, maintenance on equipment and vehicles, removal of

downed trees and plowing and cindering as needed. A motion was made by Mr. Ames to accept the road report. Mr. Manglaviti seconded the motion and the motion carried.

Unfinished Business

-A motion was made by Mr. Manglaviti to cancel the phone and fax lines that were not being used. There will be a \$203 charge to do so. Mr. Walsh seconded the motion and the motion carried.

New Business

-Frear Lane- Donna Buzon asked the Board about Frear Lane being plowed according to the agreement that she had copies of. After some discussion it was agreed that the township would plow after looking at how it could be done.

Bartoletti Agreement –There was some discussion regarding the content of the agreement and it was explained that Mr. Bartoletti would be paying the expense of having the Ordinance revision but that it still was subject to a public hearing. A motion was made by Mr. Manglaviti and seconded by Mr. Walsh to sign the agreement. All in favor and the motion carried. A motion was then made by Mr. Ames and seconded by Mr. Manglaviti to open a separate bank account with a \$5000 deposit by Mr. Bartoletti for expenses incurred by township in addressing the ordinance issues. All in favor. Motion carried.

Audience Participation:

- -Dave Kennedy complimented Mr. Walsh on how good the roads were.
- -Collin Lunger introduced himself as a candidate for coroner and Gene Dziak as his deputy should he win.
- -Mike Butts asked the Supervisors and Zoning Officer Chad Patton about the status of his permit stating that he had talked to the county and the Fish Commission. Mr. Patton stated that the permit was still with DEP and the permit will be contingent to that decision.
- -Mr. Stan Deluca questioned if the township governed the waterways and was told that the township does not. Mr. Deluca was advised that it was a question for civil court.
- -Paula Schloder and Peggy Leonhart stated that the Park Committee will meet on a Tuesday in April.

Mr. Manglaviti made a motion to adjourn. Mr. Walsh seconded and the motion carried. Meeting adjourned at 7:47. Respectfully Submitted,
