a volunteer who would paint the building at the ballfield if paint was provided. Terri spoke about getting a pickleball court or the option of using the basketball court for pickleball. They had their first meeting and a clean up is scheduled for May 21st and they need gravel. Mr. Walsh stated he would bring some. They will be working on clearing the side of the dam and would like to put a bench there. There was discussion over the bike run using the park as well as the Catholic Church. A motion was made by Mr. Manglaviti and seconded by Mr. Walsh to accept the report. All in favor. Motion carried.
