

Overfield Township
October 12, 2021
Minutes

The Board of Supervisors of Overfield Township, Wyoming County, PA., met at 7:00 P.M. at the Overfield Township Municipal Building for their tenth regular meeting for the fiscal year 2021.

Those present were Supervisor Chairman-Donald Ames ; Roadmaster-John Walsh; Sec./Treas.- Susan Smith and 5 signed in residents. John Manglaviti was absent.

Mr. Ames called the meeting to order.

The minutes of the last meeting were not read but copies were e-mailed to the Supervisors. A motion was made by Mr. Walsh and seconded by Mr. Ames to approve the minutes of the September 14th meeting. All in favor. Motion carried.

The Treasurer's report was read:

A motion was made by Mr. Ames and seconded by Mr. Walsh to accept the Treasurer's report. All in favor. Motion carried.

The bills were presented for review and discussion. A motion was made by Mr. Ames and seconded by Mr. Walsh that the bills be paid. All in favor and the motion carried.

Police Report

Officer Zdaniewicz gave the police report for the month of September. There were 30 incidents: 1 traffic citation, and no criminal arrests. A motion was made by Mr. Walsh and seconded by Mr. Ames to accept the report. All in favor. Motion carried.

Planning Commission Report

Zoning Report

Chad Patton stated there was 2 building permits and 1 razing permit issued. A motion was made by Mr. Ames to accept the zoning report and Mr. Walsh seconded it. Motion carried.

Road Report

Mr. Walsh read a summary of the road work done in September which included shop clean up, maintenance on equipment, brush cutting, potholes filled, signs put up that were knocked down, cleaned ditches on Erhardt because of the beavers, , ditch work and hauled antiskid. A motion was made by Mr. Ames and seconded by Mr. Walsh to accept the road report. All in favor. Motion carried.

Park Committee Report

Paula Schloder and Peggy Leonhart gave the park report: A meeting was held on 9/21 to plan the next clean up. Clean up was held on 9/26 and was very successful. There were 21 volunteers and 9 were Boy Scouts. The carousel pad was cleaned up and trail markers put in. They are working on grants. Petty cash paid for their supplies. The picnic tables are in the township garage. There is a broken hinge on the BB court gate. A request was made for gravel closer to the upper bridge. The next meeting is

10/19 at 7 PM and it will be the last until March 2022. The committee will meet at the firehouse for the purpose of doing grant applications. A motion was made by Mr. Ames and seconded by Mr. Walsh to accept the Park Committee report. All in favor. Motion carried.

Correspondence

-Liquid fuel estimate for 2022-\$71,912.86. In 2021 the township received \$73,011.

Unfinished Business

-A motion was made by Mr. Ames and seconded by Mr. Walsh to schedule the public hearing for the zoning ordinance changes on November 16th at 6PM. All in favor. Motion carried.

New Business

- A motion was made by Mr. Walsh and seconded by Mr. Ames to have a work session on November 4th to do the proposed budget for 2022 at 12:00. All in favor. Motion carried.

- DGK will be at the township at 6:30 prior to the regular meeting.

-A motion was made by Mr. Walsh and seconded by Mr. Ames to appoint Henry Fells and Joseph Oliver to the Zoning Hearing Board and Tom Walsh as an alternate. All in favor. Motion carried.

-Resolution 2021-1012 was passed by a motion from Mr. Walsh and a second from Mr. Ames. Resolution 2021-1012 amends the fee schedule for building permits.

Audience Participation

Mr. Collin Lunger introduced himself to the audience as a candidate for the office of coroner on the Republican ticket as asked for support in the election. Mr. Dave Kennedy suggested that the Supervisors keep their eyes on what is happening with the LLC's in California in reference to our zoning ordinance.

With no further business brought before the Board, Mr. Walsh made a motion to adjourn. Mr. Ames seconded the motion. The meeting was adjourned at 7:30 PM.
