Those present were; Chairman-Donald Ames; Supervisor- John Manglaviti; Roadmaster-John Walsh; Sec. / Treas. - Susan Smith; Police Chief- Ed Morristell: State Police Sergeant-William Mackiw and 6 signed in residents.

The minutes of the regular meeting of September 12, 2023 were not read as copies were e-mailed to all supervisors prior to the meeting. Mr. Walsh made a motion that the minutes be accepted as written. Mr. Ames seconded the motion. All in favor. So carried

The bills were presented for review and discussion. A motion was made by Mr. Ames that the bills be paid. This motion was seconded by Mr. Walsh. All in favor. So carried.

Solicitor's report: None Planning Commission report:

Susan Smith read the Planning Commission's minutes from their September meeting. Mr. Manglaviti made a motion to accept the September minutes. Mr. Walsh seconded the motion. All in favor. So carried.

Zoning report:

Chad Patton gave the zoning report for September. There were 2 permits for the month. A motion was made by Mr. Ames to accept the zoning report. The motion was seconded by Mr. Walsh. All in favor. So carried.

Road Report:

Mr. Walsh gave a summary of the road work done in September: brush mowing; graded Mislevy Road and Erhardt Road; assisted Lemon Township; cleaned boxes and pipes on Pete Hill and Dolph; clean up after storms; Township clean up; scrap taken to Scranton and miscellaneous maintenance on equipment A motion was made by Mr. Manglaviti to accept the report. Mr. Ames seconded the motion. All in favor. So carried.

Police Report

Chief Morristell gave the report for September: There were 39 incidents: 2 traffic citations, 1 traffic warnings, and 1 criminal arrest with 4 charges (DUI). Sergeant William Mackiw addressed the board stating that he was trying to visit all the municipalities. He encouraged the township to call for assistance if needed. Kevin Michaels spoke about the 4 wheelers that are always on Ross Road and that the police are not doing anything. Chief Morristell explained the difficulty in citing a person and that the cases they have taken to court have not been successful. A motion was made by Mr. Manglaviti and seconded by Mr. Walsh to accept the report. All in favor. So carried.

Park Committee Report

Paula Schloder and Terri Ace-Lehnert gave the report: park fund raiser will be on the 21st and there are a lot of prizes for the contests such as a \$200 prize for the best chili. There will be vendors and a pumpkin patch that has been donated by Trevor Brown. There will be a bounce house that was donated and decorations that have been donated. Permit parking has been done and the fire company will be there. 2-4 is the time for the littler children and 7-9 for the older kids/adults. There is still some work to be done on the trail A motion was made by Mr. Manglaviti to accept the report. Mr. Walsh seconded the motion. All in favor. So carried.

There is a solar farm section being added. The supervisors took the recommendations of the Planning Commission and a motion was made by Mr. Ames to update the draft. Mr. Manglaviti seconded the motion. All in favor. So carried.

- -A budget work session- A motion was made by Mr. Manglaviti to have a budget work session on November 2nd at 4 PM. Mr. Walsh seconded the motion. All in favor. So Carried.
- Meeting with DGK- 6:30 on December 14th DGK will review the insurance plan.

Pat Rudisail asked why all the trees were cut down and was told that it is right now just timbering. There was discussion regarding the water company putting in pipe. There was discussion regarding the Pelican and the changes made. Chad stated that he was working with Art Russo and that a roof was being put on and he was talking about enclosing some of the block.
