Zoning report:

Chad Patton gave the zoning report for August. There was 1 permit for the month for a new home and one sewage permit. A motion was made by Mr. Walsh to accept the zoning report. The motion was seconded by Mr. Manglaviti and the motion passed.

Road Report

Mr. Walsh gave a summary of the road work done in August which included: crack sealing with Tunkhannock Township om Middle Mountain Road; brush cutting; FDR on Orchard; boxes on Marina Lane; cut trees; road signs up; yard work; PM on equipment; and tires were put on pickup.
