The minutes of the reorganization meeting and the regular meeting of January 6th were not read as copies were e-mailed to all supervisors prior to the meeting. Mr. Walsh made a motion that the minutes be accepted as written. Mr. Manglaviti seconded the motion. All in favor. Motion carried.
