The Board of Supervisors of Overfield Township, Wyoming County, Pa., met at 3:30 P.M. at the Overfield Township Municipal Building for their tenth regular meeting for the fiscal year 2024.

Those present were; Chairman-Donald Ames; Vice Chairman-John Manglaviti; Roadmaster- John Walsh; Sec. / Treas. - Susan Smith; Atty Tom Daniels; Sara Thaxton; William Wilson; Dave Kennedy and Paula Schloder.

This meeting was rescheduled from October 8 due to lack of a quorum. The meeting was suspended for the purpose of letting Attorney Tom Daniels address the Board. Attorney Daniels stated that he represents Sara Thaxton and William Wilson and that he was there to tell the Board that there is a possible conflict regarding water runoff at residents of Point Road (#234 & #226). Attorney Daniels stated that he knew that this was a civil matter and that the Township had no responsibility in this but that he wanted the Supervisors to be aware. The heavy rains had caused some flooding and Mr. Wilson stated that he had taken precautions by putting drains in. The minutes of the regular meeting of September 10th were not read as copies were e-mailed to all supervisors prior to the meeting. Mr. Walsh made a motion that the minutes be accepted as written. Mr. Manglaviti seconded the motion. All in favor. So carried

Mr. Walsh gave a summary of the road work done in September: mowing, equipment maintenance calcium on roads, cut grass at park, worked with other townships on various road projects, and attended a Dirt & Gravel Roads class in DeBois. There was some discussion regarding the low turnout for clean up this year and whether it should be a yearly or every other year event. It was discussed that maybe more advertising such as the fire companies sign be utilized.

Don Ames gave the police report for September: There were 11 incidents: 1 traffic citation, 0 traffic warnings, no criminal arrests, 3 hours vascar, 50 hours patrol and 15 hours for incidents. A motion was made by Mr. Manglaviti to accept the police report. Mr. Walsh seconded the motion. All in favor. So carried.

Paula Schloder gave the following report for the park committee: Halloween Fund raiser October 26th, Paperwork was given to all the volunteers for liability release, there are new activities for the kids, hole is in fence but no gate as of yet, Fish Commission should be the ones to cite people on side-by-sides.
