The Board of Supervisors of Overfield Township, Wyoming County, Pa., met at 7:00 P.M. at the Overfield Township Municipal Building for their eleventh regular meeting for the fiscal year 2024.

Those present were; Chairman-Donald Ames; Vice Chairman-John Manglaviti; Roadmaster- John Walsh; Sec. / Treas. - Susan Smith; Zoning Officer-Chad Patton; Polic Chief- Ed Morristell and 3 audience members.

Mr. Ames announced that an Executive Session had been held on October 29<sup>th</sup> from 12:55 -1:05 PM regarding a personnel issue. The minutes of the regular meeting of October 11<sup>th</sup> were not read as copies were e-mailed to all supervisors prior to the meeting. Mr. Walsh made a motion that the minutes be accepted as written. Mr. Manglaviti seconded the motion. All in favor. Motion carried.

Chad Patton gave the zoning report for the month of October. There were 3 building permits. A motion was made by Mr. Walsh that the report be accepted. Mr. Manglaviti seconded the motion. All in favor. Motion carried.

**Road Report:**

Mr. Walsh gave a summary of the road work done in October: brush mowing, equipment maintenance, calcium on roads, cut grass at park, regraded some roads and replaced pipe and did ditch work on Purdy Road. A motion was made by Mr. Ames to accept the report. Mr. Manglaviti seconded the motion. All in favor. Motion carried. Mr. Walsh announced that Senator Lisa Baker called and is giving us \$250,000 for repairs on Erhardt Road since we did not get the LSA grant.

**Police Report**

Chief Morristell gave the police report for October: There were 29 incidents: 2 traffic citation, 0 traffic warnings, 1 criminal arrest, 3 hours vascar, 45 hours patrol and 30 hours for incidents. A motion was made by Mr. Manglaviti to accept the police report. Mr. Walsh seconded the motion. All in favor. Motion carried.

### **Park Committee Report**

Christine Lebar-Sheehan gave the following report for the park committee: Halloween Fund raiser made \$3,137.70 after costs and next year it will be October 18<sup>th</sup> with a day hike only, June 28<sup>th</sup> chicken BBQ, looking for corporate donations next year; modified stone, donated will need to be spread, there were 218 on the day hike and 20 on the night hike and a volunteer appreciation get together will be 11/18 at the Mill City Dairy Bar. A motion was made by Mr. Walsh to accept the Park Committee report. Mr. Manglaviti seconded the motion. All in favor. Motion carried.

- Mr. Walsh made a motion that the budget be open for inspection beginning November 13<sup>th</sup>. Mr. Manglaviti seconded the motion. All in favor. Motion Carried.
- Liquid Fuels Audit by auditor general for 2023 has been completed. Books are reported to be in good order.
- Tony Hug resignation- The resignation for Tony Hug on the Zoning Hearing Board was read. Mr. Walsh made a motion to accept Mr. Hug's resignation and to appoint Paula Schloder in his place. Mr. Manglaviti seconded the motion. All in favor. Motion carried.
