The Board of Supervisors of Overfield Township, Wyoming County, Pa., met at 7:00 P.M at the Overfield Township Municipal Building for their seventh regular meeting for the fiscal year 2025.

Those present were; Chairman-Donald Ames; Vice Chairman-John Manglaviti; Roadmaster- John Walsh; Police Chief- Ed Morristell and Sec. / Treas. - Susan Smith

The minutes of the June 10th meeting were not read as copies were e-mailed to all supervisors prior to the meeting. Mr. Walsh made a motion that the minutes be accepted as written. Mr. Manglaviti seconded the motion. All in favor. Motion carried.

A motion was made by Mr. Ames to accept the Treasurer's report. Mr. Walsh seconded the motion. All in favor. Motion carried.

The bills were presented for review and discussion. A motion was made by Mr. Walsh that the bills be paid. This motion was seconded by Mr. Manglaviti. All in favor. Motion carried.

Zoning report

Susan Smith gave the Zoning report for June. There were 4 permits issued, 1 certificate of nonconformance for a lot and garage on Dolph Lane and the Zoning Hearing Board had a continuation hearing for 0 Frear Lane. Mr. Manglaviti made a motion to accept the Zoning report. Mr. Walsh seconded the motion. All in favor. Motion carried.

Road Report:

Mr. Walsh gave a summary of the road work done in June : Grading has been completed with the exception of a couple spots to fix; brush cutting in process; assisted Tunkhannock and Lemon Township; Pipes have been ordered for the Dolph project. Mr. Walsh also stated that an electrician will need to be hired because some of the overhead lights in the offices and meeting rooms are not operating properly. A motion was made by Mr. Ames to accept the road report. Mr. Manglaviti seconded the motion. All in favor. Motion carried.

Police Report

Chief Morristell gave the police report for June: There were 21 incidents: 2 traffic citations, 1 traffic warnings, no criminal arrests, 4 hours vascar, 45 hours patrol and 25 hours for incidents. A motion was made by Mr. Manglaviti to accept the police report. Mr. Walsh seconded the motion. All in favor. Motion carried.

-Resolution 2025-0708- Resolution to pass a resolution to adopt the County EMA Operations Plan. Mr. Manglaviti made a motion to pass Resolution 2025-0708. Mr. Walsh seconded the motion. All in favor. Motion carried.

-County Aid- Mr. Walsh made a motion for Treasurer, Susan Smith, to offset an expense in the General Fund with the county aid of \$2,227.61. Mr. Manglaviti seconded the motion. All in favor. Motion carried.

-Winter Agility- There was discussion regarding the Winter Agility Agreement with PennDOT for 2025-26 season. There are 3 options offered to the township: Option 1- Status Quo of past years; Option 2- adding roads and banking payment for tar and chipping (2.5 miles after 5 years); and Option 3-adding roads and banking payment for tar and chipping (5 miles in 5 years). (See Winter Agility File 2025-26) After some discussion, Mr. Manglaviti made a motion to accept the third option of adding roads and banking payments for 5 miles of tar and chip after 5 years. Mr. Ames seconded the motion. All in favor. Motion carried.
