The Board of Supervisors of Overfield Township, Wyoming County, Pa., met at 12:00 P.M at the Overfield Township Municipal Building for their eleventh regular meeting for the fiscal year 2025.

Those present were; Chairman-Donald Ames; Vice Chairman-John Manglaviti; Roadmaster- John Walsh; Sec. / Treas. - Susan Smith; Chief Ed Morristell; Park Committee: Paula Schloeder; auditor-David Kennedy and resident Mark Frisco. Also present were township solicitor Bob Sheils and LWMA engineer John Devine.

Mr. Ames suspended the order of business and asked Atty. Sheils and Mr. Devine to speak currently to allow them to leave the meeting and attend to other business. Atty Sheils stated that the township was obligated to guarantee the loan taken by LWMA. There is paperwork that needs to be filed and sent to the state showing debt ratio. All paperwork was given to CPA Eric Davis to complete. It will then be submitted to DCED for approval and Ordinances will have to be advertised and passed before the closing with Pennvest in February. There have been 2 grants awarded to LWMA for millions of dollars and Mr. Devine was given thanks for his hard work.

The minutes of the October 12<sup>th</sup> meeting were not read as copies were e-mailed to all supervisors prior to the meeting. Mr. Manglaviti made a motion that the minutes be accepted as written. Mr. Walsh seconded the motion. All in favor. Motion carried.

A motion was made by Mr. Ames to accept the Treasurer's report. Mr. Walsh seconded the motion. All in favor. Motion carried.

The bills were presented for review and discussion. A motion was made by Mr. Walsh that the bills be paid. This motion was seconded by Mr. Manglaviti. All in favor. Motion carried.

**Zoning report**

Susan Smith gave the Zoning report for October. There were five (5) permits issued; no (0) certificate of nonconformance; a Zoning Hearing for a variance for 452 Point Road was granted to allow the porch to remain. No enforcement notices were sent. Mr. Walsh made a motion to accept the Zoning report. Mr. Ames seconded the motion. All in favor. Motion carried.

**Road Report:**

Mr. Walsh gave a summary of the road work done in October: wind storm clean up; filled potholes; Sikora Brothers bermed Dolph Lane; equipment was prepped for winter; and worked with Lemon Township. A motion was made by Mr. Ames to accept the road report. Mr. Manglaviti seconded the motion. All in favor. Motion carried.

**Police Report**

Chief Morristell gave the police report for October: There were 22 incidents: 1 traffic citations, 0 traffic warnings, 1 criminal arrest, 4 hours vascar, 40 hours patrol and 28 hours for

incidents. A motion was made by Mr. Manglaviti to accept the police report. Mr. Walsh seconded the motion. All in favor. Motion carried.

#### **Park Committee Report**

Paula Schloder gave the park committee report: The Halloween Trail hike for the kids was a success, there was a lot of good feedback. United Methodist Church gave out cider and donuts and children's books. There were a lot of donations and Reeves donated a Portable potty for use. The day was beautiful and using the carousel pad was a good idea. Mt Walsh made a motion to accept the Park Committee report. Mr. Manglaviti seconded the motion. All in favor. Motion carried.

#### **Correspondence**

-Assessor's office- A veteran exemption for taxes has been given to Eric Hubbard.

#### **Unfinished Business**

-Franchise Agreement with Comcast- tabled pending response from PSATS regarding if it is permissive having 2 franchise agreements in the township.

#### **New Business**

-A copy of the EMA agreement naming Cody Stanco as the EMA Coordinator for Overfield Township as well as with Falls Township was signed by the supervisors and the Secretary. Copy to be signed by Falls Township Supervisors and Secretary and forwarded to Ralph Swartz per his request.

-A motion was made to pass Resolution 2025-1112 by Mr. Walsh. Mr. Manglaviti seconded the motion. All in favor. Motion carried. (Resolution for Phase II Teener Field Grant)

-Ordinance changes- There was some discussion between the Supervisors and Chief Morristell as to passing a solicitation ordinance. It was decided to forego the ordinance at the present time and that 'NO SOLICITING' signs be made and posted in the township.

-Mr. Ames stated that the 2026 budget is available for inspection. There will be a fire tax increase from .4 mills to 1.0 mills for 2026.

#### **Audience Participation:**

-Mark Frisco asked if it was possible to use the Teener field for a travel team this coming season. Mark stated that he would make the upgrades that were needed using his own equipment.

With no further business brought before the board, Mr. Manglaviti made a motion to adjourn. Mr. Walsh seconded the motion. All in favor. So Carried. Meeting adjourned at 12:38 PM.
