Motion was made to adjourn by Sorensen and Seconded by Hutchings.

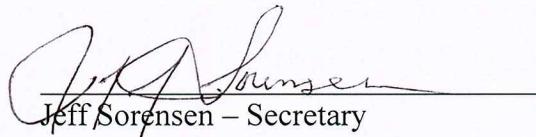
