This agreement is for the purpose of raising capital for a film written and directed By Author ZEEKIE, who has a contract deal or partnership with SNEAKPROOF PUBLICATIONS. Title of project Straight Shooter. Project should start filming December 2024. These investment will not exceed \$1,000.00 USD that will deposited into a secure account. There will be this agreement signed by investor and SNEAKPROOF WHEN MONEY HAS BEEN DEPOSITED. Also moneys will need to be document with name address date time deposite amount and time. The Investee will reciece in return .25 per \$1.00 USD totaling a \$250 return on a \$1,000. 00 investment. Any money given above this limit but less than \$1,000.00 USD will be consider a donation to futher the completion of the project.

These funds will be used appropriately to seal contracts with film crew and some actors and actress payout. Also funds can be distrubited how needed to bring Straight Shooter to comepletion. NOTE: THIS INVESTMENT IS HIGH RISK AND IT IS POSSIBLE UPON COMPLETION OF THE STRAIGHT SHOOTER PROJECT THAT THE FILM COULD NOT PRODUCE A RETURN OR IT'S INITIAL INVESTMENT. Investee will be offer a credit on the film stating its contribution. investee will have access to the film showing on opening night alongside with a guess. The investee will have access to all red carpet passes. repayment of investment should beging one year after the completion of the film Straight Shooter. If funds are available payment will be one lump sum of the total return on the investment of \$1,250.00 USD. If funds did not return on investment then SNEAKPROOF has the option to pay on return in a dividend format of monthly payments. \$20.04 monthly over a 48 month period. if this last repayment option is not available then SNEAKPROOF SHALL SEND OF LETTERS TO INFORM ALL INVESTEES THAT THE INVESTMENT HAS BEEN LOST.
