Conditions under which reproduction rights are granted for images of items in the collections of The Danbury Museum & Historical Society Authority (“DMHSA”)

1. All requests for permission to reproduce an image in any form must be made in writing and include the intended use, the publisher, and the date of publication.
2. The purchase of an image does not in itself carry with it the right to make a reproduction in any form. Copyrights of all images remain property of DMHSA.
3. Upon publication, DMHSA will be provided with a complimentary copy of the publication (book, catalog, periodical, film, video, etc.) in which the image is reproduced.
4. Publication is permitted only from images directly supplied by DMHSA.
5. Each image must be reproduced in its entirety and without any alteration, including cropping, bleeding off the page, overlapping, overprinting, or change in color, unless otherwise approved in advance by DMHSA. Any altered or detailed image must be labeled as “DETAIL.”
6. The complete credit line as supplied by DMHSA must appear in the caption or list of credits for each reproduction.
7. DMHSA assumes no responsibility for any royalties or fees claimed by the artist or on the artist’s behalf. In the case where copyright is held by a third party, written permission must be secured by the applicant from that third party or their agent and must accompany the application.
8. Rights to reproduce are non-exclusive and are granted for one-time use only, as detailed on the application form. Any further revision, editions, re-printings, eBooks, or additional use requires a new application to be submitted.
9. Permission is valid only for the individual, company, or institution to whom it is specifically issued and may not be transferred, assigned, sold or otherwise disposed of without written permission of DMHSA.
10. **Permission is not granted, nor will images be sent for scanning, until all the required fees are paid to DMHSA.**
