Wayne County Saddle Club Standard Waiver Form

All participants are requested to complete and sign this waiver of liability form upon entering Wayne County Saddle Club Property. Persons involved in events sign this waiver on the entry form when they complete the entry form. This waiver is for all other participants. Other participants include but are not limited to: Spectators, ring crew, judges, show stewards, grounds keepers, grooms, parents, grandparents, guardians and all other paid or volunteer help. This also includes anyone present at equine activities.

Further, participant understands that there are inherent risks involved in dealing horses and ponies. Participant understands that: (7) "Inherent risk of an equine activity, including, but not limited to, any of the following: (a) The propensity of an equine to behave in ways that may result in injury, death, or loss to persons on or around the equine; (b) The unpredictability of an equine's reaction to sounds, sudden movement, unfamiliar objects, persons, or other animals; (c) Hazards, including but not limited to, surface or sub-surface conditions; (d) A collision with another equine, other animal, a person, or an object; (e) The potential of an equine activity participant to act in a negligent manner that may contribute to injury, death, or loss to the person of the participant or to other persons, including, but not limited to, failing to maintain control over an equine or failing to act within the ability of a participant. Refer to O.R.C. section 2305.321 (A) (7) (a-e).

With full understanding of inherent risks involved in equine activity, some described above, participant agrees to Waive, release and hold harmless Wayne County Saddle Club and (all) others defined in O.R.C. 2305.321 from tort and civil liability arising from or related to participation in equine activity as outlined in section 2305.321 of the Ohio Revised Code. The agreement also releases all volunteers, agents, independent contractors and maintenance personnel and others associated with the event. This waiver agreement is made and entered into the State of Ohio and shall be enforced and interpreted under the courts and laws of the State of Ohio. It is the participant's sole responsibility to read and understand section 2305.321 of the Ohio Revised Code.

Note: Participant includes spectators and others attending functions, not actually riding or showing a horse.
