2. Terms of Payment for Services/Training or Boarding:

- Boarding ONLY Clients- \$30 per night for first animal, \$25 per night for additional animals.
 - Training \$850 per four weeks
 - Includes
 - Boarding
 - Food
 - Easy Lead (1 per animal)
 - Homing Pigeons
 - ALL other shooter birds will be billed out at send home at current market value.
 - All fees will require an additional 4.5% South Dakota State Sales Tax added to them.
- A. Owner shall make a non-refundable deposit of \$250 to reserve services/training time.
1. This will be credited towards the first four-week training fee which is due at drop off. Payment must be received within 14 days of final reservation confirmation.
 2. Owner and MXK agree that the time amount estimated for services may need to be modified based on the dog's progress in the training sessions and/or based upon services actually provided.
 3. Owner agrees that all fees and charges are to be paid in full at conclusion of training and pick up of animal. Owner understands and agrees that MXK shall have a possessory lien on Owner's dog which lien shall remain in effect until Owner's account with ABK is paid in full. The possessory lien hereby granted to MXK includes the right of sale of Owner's dog if MXK must do so to recover the fees owed under this agreement.
- B. Owner Responsibility for Dog's Health:
1. Owner is responsible for having the following vaccination shots current on the dog(s):
 - 1) rabies/distemper
 - 2) kennel cough (Bordetella) (within the past twelve months).
 - 3) Evidence of vaccinations provided by a licensed doctor of veterinary medicine is required on or before the day a dog arrives for services/training.
- C. Additional Terms:
1. **HOLD HARMLESS:** The Client will hold Marzolf X Kennel, LLC harmless and indemnify MXK from any and all claims, liability, damage, loss or expenses arising out of any injury to any persons or to any person's property by Owner's dog(s) while said dog is in the care, custody and control of ABK.
 2. Owner acknowledges that dog training will not provide exact results. Each dog is different in regards to ability, intelligence and temperament. MXK makes no expressed or implied guarantee as to the results reached in training or regarding the level of competency that will be reached by Owner's dog(s).
 3. MXK reserves the right to terminate this agreement at any time, and to request that Owner pick up their dog(s). All pre-paid training fees will be non-refundable and all fees due will be required to be paid at pickup of the animal in the event MXK makes such request.
 4. MXK shall not be responsible for the cost of replacing Owner's dog(s) or for any damage of any kind, should Owner's dog(s) die, be stolen, escape, or become injured, or ill while in the care of MXK. Proper care will be given up to and including veterinarian care needed

with all expenses being the responsibility of the owner of the animal. Accepted training methods will be followed while dog(s) is (are) in MXK's care.

5. Owner and MXK agree that this written agreement sets forth the entire agreement of the parties – there are no oral or other unwritten terms of the agreement.

6. At the conclusion of the agreement and at such time as Owner picks up Owner's dog, Owner will receive a complete send home video of dog's ability along with a written list of instructions to continue enforcing skills learned in the training. Obedience trained dogs will receive a hands on demonstration of the skills taught. In the event that Owner has any questions or concerns about the skills taught to Owner's dog Owner must present said questions or concerns to MXK within 30-days of the conclusion of training in order for MXK to adequately and properly answer the question or provide necessary correction.

D. Media Release

1. I, the undersigned, do hereby consent and agree that MXK and its employees, or agents have the right to take photographs, and/or digital recordings of our dog or dogs and all family members while training and to use these in any and all media, now or hereafter known, and exclusively for the purpose of MXK advertising and social Media. I further consent that my first name and identity may be revealed therein or by descriptive text or commentary. I do hereby release to MXK, its agents, and employees all rights to exhibit this work in print and electronic form publicly. I waive any rights, claims, or interest I may have to control the use of my first name or likeness in whatever media used.

2. I understand that there will be no financial or other reimbursement for recording myself, either for transmission or playback.
