Competition will be held at the Towne East Square, 7700 E. Kellogg, Suite 1300, Wichita, Kansas. Fields will be set up on Thursday July 25th starting at 8:00 AM. All members are encouraged to come out and assist and get a layout of the facilities.

The Executive Meeting will be held on Thursday August 25th at 1:30 PM at Midian Shrine . The address is 130 N. Topeka, Wichita, Kansas. The Nobles meeting will be held at 3:30 PM the same day at the Midian Shrine. All Competition times and information on Competition and parking will be given at this Meeting. All Awards Banquet tickets will be available prior to and after the meeting.

The Awards Banquet will be held on Friday, August 26th, 2022, at the Drury Plaza Hotel Broadview in the Bosin Ballroom. The address is 400 W. Douglas Ave, Wichita, Kansas. There will be a social hour with a cash bar starting at 6:00 PM and dinner will be served at 7:00 PM. Awards will follow dinner. The cost is \$45.00 per person, and we will be serving a plated meal with Sauteed Chicken **and** London Broil on each plate with fresh grilled vegetables and twice baked potato. Every table will be preset up with Salad, Bread, Tea, and water. Desserts will be on a serving table so you can pick between Assorted Cakes flavors of Chocolate, German Chocolate, Carrot and Wedding White. Soft drinks are included with meal.

There will be assigned seating. Seating will be assigned by Units if all reservations are made on the same form. Checks and the Reservation Form **must be RECEIVED no later than August 5th, 2022**. Register early because seating will be assigned by date received.

All Units who desire to enter Competition in any form must be in good standing with dues paid to CSASMC. Registration for Competitive Drill, Obstacle Course, Show Car, and Show Bike Competition must be made with the Secretary no later than August 1, 2021. That Date is firm because we must have ample time to order trophies. Any Unit registering late will still be able to compete, but it **MAY** be in a consolidated class and will be assessed a \$25.00 late registration fee **AND** no trophies will be presented. Registration forms may be sent by regular mail or email only at the addresses on the form. A return reply will be sent verifying your registration **if a contact name and address is given on the form**. If you do not receive a return reply within days, contact the Secretary to be sure that it was received.

2022 COMMENTS AND REMINDERS (again)

COMPETITIVE DRILL: Motor vehicles are to be inspected prior to Competitive Drill as they are to be operated during the drill. No miscellaneous items are to be added or removed between inspection and riding the drill.

A stop line will be painted 20' past the exit gate on each Competitive Drill Field. The lead member of each Unit must come to a complete stop before crossing the line. Any Unit not coming to a complete stop will be disqualified.

Field size: 120' x 240'

Discussion was held on the clarification for flag vehicles and the following was determined: A flag vehicle will be allowed in Competitive Drill. The flag vehicle will enter the drill field and come to a complete stop in a position on the field so as not to interfere with the drill. The flag vehicle shall remain in this position until the drill is complete, then exit the field. Only one flag vehicle will be allowed.



If a vehicle becomes disabled on the Competitive Drill Field, the driver should move the vehicle to a safe location on the field so as not to interfere with the remainder of the drill or stay seated in the vehicle.

SHOW CAR/SHOW BIKE In the past, occasionally a judge would score an item that was not on the score sheet. After a Unit has completed their inspection, the sheets will be collected, and a committee will review them to make sure that a judge did not add any additional items that are not on the sheet. If they find any additional deductions that are not allowed, they will make that correction and bring this item to the judge's attention.

COMPETITION REGISTRATION: In the past there have been Units that have waited until after the competition registration deadline to register for competition. No Unit will be penalized any point deductions for late registration but will be charged a \$25.00 registration fee for each competition entered. The fee must be paid prior to any time assigned to the Unit.

Rule # 11 of the Obstacle Course has been modified. The rule previously stated that there will be a "safety stop line" placed 36" after the stop line in which the rider must stop the front wheel of his vehicle or be disqualified. The 36" designation was removed, and a stop line will still exist. The rider must come to a complete stop before crossing the line or be disqualified.
