Privacy Policy

This Privacy Policy ("Policy") applies to www.springbooks.biz, and Spring Books LLC ("Company") and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to the Company include www.springbooks.biz. The Company's website is an E-commerce site. By using the Company website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with services offered, the Company may collect personally identifiable information, such as your:
