Port of Garibaldi RV Park and Facility Access During COVID-19 2020 Emergency

Governor Brown has issued an Executive Order urging people to Stay at Home to Save Lives. It is essential to the health, safety, and welfare of everyone during the ongoing state of emergency that individuals minimize travel outside their local area and follow social distancing and hygiene guidelines established by the CDC and the Oregon Health Authority.

In accordance with Tillamook County, City of Garibaldi, and Port of Garibaldi Emergency Declarations, The Port of Garibaldi RV Park is currently closed to all transient lodging (less than 30 days). Therefore, the Port RV Park remains open to serve only the following designated groups:

- 1 Current users registered for longer than thirty (30) consecutive days.
- 2 Essential personnel where lodging in Tillamook County is necessary for work involving the safety of human life or the protection of property or performing certain types of other work consistent with the intent of this provision (e.g. emergency and public safety responders, truck drivers and supply providers, and construction industry workers).
- 3 Other individuals as authorized by the Tillamook County Health Authority.

The Port's ability to facilitate use of Port facilities, as well as allowing for future openings, relies largely on all user's compliance with CDC, Oregon, and Local guidance pertaining to social distancing. Port Staff, Tillamook County Sheriff's Office, and other agencies will be monitoring activity within the Port. Failure by any individual or group to follow all applicable COVID-19 guidance will constitute a violation of Port policy and may lead to a denial of services in accordance with Port of Garibaldi Ordnance 15, citations by local law enforcement, and/or the removal from the Port of Garibaldi RV Park.

We ask that anyone arriving from outside Tillamook County observe a 14-day self-quarantine upon arrival to the RV Park. This includes avoiding places where many people gather, including stores; workplaces; restaurants; and gas stations, staying off public transportation, and calling a healthcare provider promptly if fever, cough, or trouble breathing develop.

All users of the Port and its Facilities shall at all times follow the below guidance at a minimum.

- 1. Gatherings of people at all Port Facilities including the RV Park, boat ramp, docks, piers, green spaces, picnic areas, and parking lots must be limited to no more than five people.
- 2. Maintaining a six-foot distance from others must be followed at all times.
- 3. Stay in the comfort and safety of your RV and your site.
- 4. Use your own bathroom facilities.
- 5. Do not allow visitors to your RV and site.
- 6. Wear gloves and other personal protective equipment and practice proper social distancing when using public equipment such as gas pumps, pump out facilities, ticket machine, public restrooms, etc.
- 7. Stay at home/in your RV if you are feeling sick.

The Port of Garibaldi Commission and Staff are actively working with the State of Oregon and Tillamook County to insure a timely and safe opening of all facilities in accordance with the Governor's Framework for Reopening Oregon and will update this policy as soon as possible.
