The contract terms herein are prepared for the benefit of each individual, dam owner and sire owner responsible for stud services. This contract is to provide and protect both parties under a guarantee to the purchaser as set forth in this document, to assure that the service agreed upon is the service truly provided and to assure its use as intended and to prevent the exploitation of the breeds provided through unselective breeding programs and practices.

The following agreement is between <u>CHILDS BULLDOGS</u>, LS2 9JT, ("seller") for the purchase and sale of one stud service to ("buyer")

Dam owner MUST provide progesterone testing for their female. Should the female not be tested, and she does not take, no re-breed will be offered.

Stud services rendered are not to be sold or used on any other female than one presented at original contract signing. Should something happen to original dam prior to breeding and/or rebreed, the contract is still upholding to original contract that sire owners do not owe anything to dam owner.

If said dam does not take on a puppy back breeding, stud owner has the right to refuse service of a rebreed.

#### Breeding dates:

Puppy back dealings will be chosen by weeks 7-8. If two pups are born, this constitutes a litter. FIRST pick puppy will be given to stud owner. No rebreed will commence. If one puppy is born, the puppy shall go to the stud owner, and a rebreed will be offered. All Pup-back deals are for FULL AKC puppies, any false paperwork or incorrect DNA discovered will result in a charge of \$10,000.00.

If a pup-back deal is done with an out of state dam, the owner of the dam is responsible to pay for the transportation of the puppy to the sire owner by week 9 with proof of deworming, and vaccine records.

All puppies given to <u>CHILDS BULLDOGS</u> on a pup-back service are to be of quality, health, and structure. A health certificate within 48 hours of arrival to stud owner must be provided. Should a puppy be returned in poor condition, said puppy must be replaced and/or a payment of \$10,000.00.

The seller transfers all rights, privileges, and responsibilities associated with the ownership of said ('semen") to the buyer subject to the conditions set forth below as of the date specified. This represents the entire agreement

between seller and buyer in an outright sale. The buyer agrees that <u>CHILDS BULLDOGS</u> is solely responsible for the safe transportation (at buyers' expense) of said "shipment" and agrees to pay <u>CHILDS BULLDOGS</u> upon the signature of this contract.

AKC registration on all litters will be approved by the fourth week after birth to ensure that all puppies are still living (securing stud owners blood and paper lines go to only puppies born of that litter)

<u>CHILDS BULLDOGS</u> strives to give the most value of a specimen collection limited no minimum with a maximum of 4cc. The remainder of the tube will be calculated proportionality with non-antibiotic semen extender and shipped properly chilled for next day shipping within the United States, and two-day priority shipping if international.

<u>CHILDS BULLDOGS</u> sends Viable semen, with active and strong motility and a high semen count. Should buyer request a semen analysis done professionally by a veterinarian a \$350.00 charge will be applied to the fee for time and services rendered. Should package arrive to buyer and a "Claim of dead semen" be announced, a full work-up and analysis must be emailed or sent to <u>CHILDS BULLDOGS</u> within one hour upon arrival.

**CHILDS BULLDOGS** is not responsible for Shipping if lost, stolen, delayed or damaged.

**CHILDS BULLDOGS** presume that two live puppies born is considered a litter. **CHILDS BULLDOGS** nor the sire to the litter is responsible for the number of eggs produced by the female. Should the female in the breeding not take on the first breeding, provided with proof by a licensed veterinarian; **CHILDS BULLDOGS** will provide one breeding for repeat, but shipping is again at buyer's expense. If the breeding does not take for a second time, there will be no more available rebreeds and the sire owner no longer owes anything pertaining to the items listed in this contract. Dam owner agrees to use semen in one insemination.

**CHILDS BULLDOGS** presumes that dam owner will notify once heat cycle has begun. This is including but not limited to the first signs of swelling. **CHILDS BULLDOGS** is not responsible for lack of organization skills and last-minute planning. If we are not notified within a minimum of 24 hours prior to shipping, a \$500.00 (emergency rushed) fee will be applied.

**CHILDS BULLDOGS** is not responsible for any DNA health test findings of DM, IVVD, or CDDY. We, through research believe these do not pertain to the breed and we do not test for these items.

Should said litter be born with cleft palates or deformities are present in the litter, this again is not qualified reasoning for a repeat breeding as many of these can take place due to lack of proper prenatal care.

Should a deposit be placed on a stud that passes away, buyer will be presented to use frozen semen off said stud. If no frozen semen is available, another stud in the sire's program will be offered of sire owners choosing to complete the breeding.
