YOUTH RULES AND REGULATIONS

Adopted November 2024

The BCFYE Board of Directors reserves the final and absolute right to interpret the rules and arbitrarily settle all matters, questions, and differences in regard to these rules. Further, these rules may be modified or deleted as deemed necessary by the BCFYE Board of Directors. Disregard of these rules and any regulations may result in forfeit of all premiums, rights, and privileges without recourse. Exhibitor tags and/or ribbons have no value as to payment of premiums as they are determined from judging records only. All premium monies are contingent upon available funds. In case the receipts of the fair are insufficient to pay the expenses and premiums in full, the premiums may be pro-rated among those entitled to the same. Errors must be called to the attention of the BCFYE Board of Directors, in writing, no later than one week after premiums payment. The BCFYE Board of Directors ensures diligence in the care and protection of all exhibits after their arrival to the correct display area, but under no circumstances will the Management or BCFYE Board of Directors be responsible for the loss, theft, injury, or damage by fire, lightning, wind, or any other agency, and the management thereof shall be indemnified by the exhibitor(s) of any and all legal or other proceedings relating there to. The BCFYE Board of Directors reserves the right to refuse any entry form.

- Youth exhibitor's showing age will be the age they are as of January 1 of the current calendar year. ▪
Beginner 7yrs. & under (noncompetitive – ribbon only)
 - Young 8 – 11 yrs.
 - Junior 12 – 14 yrs.
 - Senior 15 – 19 yrs.
- In case of space limitations, pens and stalls will be assigned as follows: Current Youth Exhibitor that has previously shown at the Bay County Fair, Bay County Youth, Bay County Adults, Non-Resident Youth, Non-Resident Adults. Application for stalls and pens must be made at the time of registration.
- Each exhibitor must complete a minimum of two (2) hours of volunteering for the Bay County Fair Board before the close of the fair. Failure to complete the required number of hours will result in loss of premiums. To sign up, a link is available on the BCFYE website: www.baycountyfair.com o
Beginners 7yrs. & under are exempt from volunteer requirements.
- All entries must be listed in the Premium Book. One Entry per Class, per Exhibitor. •
Superintendents reserve the right to combine, split, or cancel classes/events.

CODE OF CONDUCT

Exhibitors as well as their family members who violate this Code of Conduct are subject to disciplinary action including but not limited to cancellations of all premiums as well as suspension from current and future BCFYE events, at the discretion of the Bay County Fair Board. The Bay County Fair and Youth Expo Code of Conduct requires all exhibitors to refrain from the following:

- Behavior that is unruly, disruptive, or illegal.
- Any illegal activity, including possession or consumption of alcoholic beverages by minors or illegal drugs on the fairgrounds
- Foul, obscene, threatening, offensive or abusive language, gestures, or actions. •
Failing to follow instructions of show personnel.
- Fighting or physical violence of any type.
- All youth 12 yrs. and under must be accompanied by an adult for all activities, including cleanups. • Any exhibitor caught destroying property will be banned from participating in the Bay County Fair and Youth Exposition for up to 2 years.
- Above all, be KIND, HELPFUL & HAVE **FUN!**

Rules and Guidelines for All Exhibitors 8–19 Years

- Exhibitors must be able to safely exhibit their animal(s) in the show ring or be separated and judged from their pen/stall as determined by the Fair Board Superintendent.
- An exhibitor must exhibit his or her own animal. If an exhibitor cannot exhibit his or her own animal due to an injury, illness, or a situation that has been confirmed by the Fair Board Superintendent then he or she may have a person in their own age group exhibit the animal for market and non-market classes only. Prior to showing the appropriate a Fair Board Superintendent should be informed of the change.
- During the fair, exhibitors are required to bathe and fit their own animals; a parent/guardian may only assist.
- Only people appointed by the Fair Board Superintendent will be allowed to enter the show ring.

Rules and Guidelines for All Beginner Exhibitors 7 Years and Under

- If youth exhibitors are to have direct involvement with an animal, the contact must take place under the direct one-on-one assistance of a responsible parent, guardian, or adult volunteer.
- Exhibitors who are 7 years old and under may be involved with an animal on a halter or lead. They must be directly assisted one-on-one by a parent, guardian, or an adult volunteer who is on the ground holding the animal's halter or lead. This includes dairy, calf, steer, lamb, kid, goat, horse etc.
- Exhibitors who are 7 years old and under may be involved with non-halter animals such as swine, companion animals, chickens and rabbits. They must be directly assisted one-on-one by a parent, guardian, or an adult volunteer who is beside the youth.
- Exhibitors in this age range will be uniformly recognized for participation.
- Exhibitors in this age range will not participate in competitive classes or the livestock auction at the Bay County Fair.

POLICIES PERTAINING TO ALL LIVESTOCK ANIMALS

- Goats, beef, swine and sheep are to be considered large animals. Rabbits, waterfowl, wildfowl, and poultry are to be considered small animals.
- All animals must participate in market classes to sell in the livestock auction.
- All large, male market animals must have been castrated.
- All female market animals must not be pregnant
- If an exhibitor has sold a market animal at any other county fair within 365 days of the Bay County Fair, they may not show that same market species in the market class at the Bay County Fair.
- All animals must meet all current USDA (United States Department of Agriculture) and MDARD (Michigan Department of Agriculture and Rural Development) testing prior to admission in the livestock barn.
- Should an animal become lame or die prior to judging, the exhibitor may obtain permission from the Fairboard Superintendent to substitute another animal.
 - If submitting an alternate animal, you must submit photos the same as your primary animal. It needs to be clear which is primary and which is the alternative for the species. Families can have one alternate per exhibitor or per family. Alternates can only be used if your primary animal becomes lame or dies.
- During the Fair, no drugs or supplements may be administered to any animal without consent of the superintendent.

- All entries will be judged using the Danish System (A-B-C) and receive corresponding ribbon. When there is only one entry in a class, first place premium money will be paid only if the animal is deemed worthy. • Dates and times will be determined by BCFYE Board to weigh in, admit and release all animals. The weight recorded at weigh in will be the showing and selling weight.
- All exhibits brought to the fair must be clean, dry, free of disease, free of parasites and uninjured. Any animals deemed sick, dirty etc. will be sent home.
- Upon entry into the livestock barn, all animals will be inspected by the Fair Board Superintendent or his/her designee to determine suitability.
- Sick or injured exhibits will be released or removed only by the direction of the Fairboard Superintendent prior to the end of the fair.
- Any exhibits removed from the fairgrounds before the designated release time without permission of the superintendents will result in the revocation of premiums.
- Animals may be re-weighed one time after initial weigh-in. Re-weigh must be completed before the end of designated weigh-in time. This may be done only if the animal produces a weight that is lower than the minimum weight required to sell in the Bay County Fair Livestock Auction. All youth wishing to re-weigh an animal must remain in the barn in order to re-weigh.
- If an animal does not make minimum weight, youth may request to show that animal in non-market and showmanship classes if they do not already have an entry in that class.
- The same animal cannot be shown in both a market and non-market class.
- Animals are not to be exhibited in multiple market/non-market classes. Animals exhibited as a single may not also be exhibited as a pen.
- Parents and members intending to participate in any livestock project (including market, non-market, or showmanship classes) must review these rules and regulations and sign a form indicating they have done so. The form must be returned to the BCFYE Office by May 15 each year. Deadline exceptions may be made by Fairboard Superintendents for new exhibitors and other special circumstances.
- **Physical color** pictures of large market animals, including alternates, must be submitted to the BCFYE Office by May 15 each year. Ear tag numbers should be visible in animal pictures.
- All exhibitors showing/selling an animal must attend at least one pre-fair set-up event. A few dates will be given each year. If the exhibitor is not available, prior arrangements must be made with a superintendent for an alternate person to complete the duties.
- All exhibitors must attend a post-fair clean-up Sunday morning. If the exhibitor is not available, prior arrangements must be made with a superintendent for an alternate person to complete the duties.
- No exhibited animals are allowed in the camping area.

Ear Tagging

- All animals **MUST** have the appropriate USDA tagging prior to entry in the barn. • Hogs and Cattle **MUST** have an official USDA tag in place prior to entry to the barn. The Bay County Fairboard will **NOT** be tagging animals at the arrival of the fair. Animals cannot be unloaded without official USDA tags in place.
- Goats & Sheep **MUST** have a scrappies tag in place prior to check-in to enter the barn. • USDA tags can be obtained by your breeder or online at: <https://www.michigan.gov/mdard/animals/id/movement>

Rules and Guidelines for the Market Sale

- All exhibitors are required to contribute 3% of their market sale income to the Bay County Fair Board and Youth Exhibition to be used for general expenses incurred throughout the year and during the fair and market sale. This amount will be deducted by the market auction clerk before checks are mailed to members.
- Once an animal has been judged in a market class during the fair you have agreed to sell the animal at the Bay County Fair & Youth Expo Livestock Auction. No animals may be removed from the sale once judging has been completed.
- **Exhibitors may register for a maximum of three (3) livestock market entries. The market entries cannot be the same species, with the exception of market production Chickens and Ducks.**
- No pregnant animals may be exhibited in market classes.
- The buyer has the right to do with the animal whatever he or she sees fit, including but not limited to donating it back to the youth, sending it to resale, or butchering it. MDARD requirements must be followed at all times.
- Sale order of all market species will be rotated each year following the adopted rotation: goats, ducks, lambs, geese, rabbits, swine, chicken, steer, pheasant/chukar, turkeys with the top listed species rotating to the bottom of the order in the following year.
- Sellers must find out the buyers' intentions for their animal(s) as soon as possible and no later than Friday afternoon. It is highly suggested that parents and youth speak with buyers the evening of the auction.
- All exhibitors who sell a market project at the Bay County Fair Livestock Auction must complete Youth for the Quality Care of Animals (YQCA) training annually. YQCA is designed to educate youth in eliminating volatile drug residues, increase food safety practices, and overall improve the knowledge of animal care and management practices. Proof of completing the course must be turned in with fair entry registration.
- Each family is responsible to contribute to the buyer's reception.
- All exhibitors and parents should be available to help set up on the day of the sale.
- No glitter or paint may be put on any animals during the market sale.
- All exhibitors are responsible for the delivery of all purchased animals to either the stockyard, processor, or to the buyer directly live or processed. Any exhibitor that fails to deliver any purchased animal to their buyers within 1 month of the auction will not be allowed to sell in the following year's sale and must return the funds received from the sale. The 3% is not refundable.

Livestock Animal Policies

Beef

- Youth must have steer/heifer in their possession by March 15 of the current calendar year in order to sell at the livestock auction.
- All Beef must have an official USDA tag in place prior to unloading for fair check-in.
- Youth may only show either a market beef or market dairy steer/heifer, not both.
- No rings in the noses of the steer.
- Steers/heifers must be born on or after January 1 of the prior calendar year and weigh a minimum of 1,000 pounds in order to participate in market classes.
- All beef must be dehorned or scurs less than 2 inches in length.

Swine

- Exhibitors are to have swine in their possession by May 15 of the current calendar year in order to sell at the livestock auction.
- All Swine must have an official USDA tag in place prior to unloading for fair check-in.
- Swine must be born on or after January 1 of the current calendar year and must weigh a minimum of 200 pounds to participate in market classes. Swine over the weight of 300 pounds will sell at the auction for 300 pounds. The Buyer will only pay up to 300 pounds at the Livestock Auction.

Sheep

- Exhibitors are to have market lambs in their possession by May 15 of the current calendar year in order to sell at the livestock auction.
- All sheep must have a scrapie tag in place prior to unloading for fair check-in.
- Market lambs must be born on or after January 1 of the current calendar year and weigh a minimum of 90 pounds to participate in market classes.

Goats

- Exhibitors are to have goats in their possession by May 15 of the current calendar year in order to sell at the livestock auction.
- All goats must have a scrapie tag in place prior to unloading for fair check-in.
- Market goats must be born on or after January 1 of the current calendar year and weigh a minimum of 50 pounds to participate in market classes.
- Pygmy breeds may not be entered in market classes.

Waterfowl and Poultry

- Market waterfowl and poultry must be born on or after January 1 of the current calendar year. • Exhibitors are to have market waterfowl and market poultry in their possession by June 15 of the current calendar year.
- All poultry and Game Birds are subject to pullorum testing during the weigh-in procedure at fair.
- To participate in the market classes, turkeys must weigh a minimum of fifteen (15) pounds. • To participate in the market classes, ducks must weigh a minimum of five (5) pounds. • To participate in the market classes, geese must weigh a minimum of eight (8) pounds. • To participate in the market classes, chickens must weigh a minimum of five (5) pounds. • Under this Waterfowl and Poultry section, the preceding rules apply to pens of multiples and minimum weight requirements for each animal class must be met.
- Market Production Pen Chickens: three (3) females, same breed and same variety (these are egg laying type chickens). Must be under one (1) year old. Minimum combination weight of all three hens is five (5) pounds total.
- Market Production Pen Ducks: three (3) females, same breed and same variety (these are egg laying type ducks). Must be under one (1) year old. Minimum combination weight of all three hens is five (5) pounds total.
- A pen of poultry or waterfowl is considered 3 animals.

Rabbits

- Market rabbits must be born on or after January 1 of the current calendar year.
- Members are to have market rabbits in their possession by June 15 of the current calendar year. • Market rabbits must weigh a minimum of four (4) pounds each to participate in market classes. This rule also pertains to pens of multiples.
- A pen of rabbits is considered 3 animals.

Pheasants/Chukars/Quail

- All pheasants/chukars/quail to be shown in the market class at fair must be acquired through the Fair Board Pheasant Contact. This assures age equality and pullorum-free birds. Birds are ordered in late spring, approximately 10-12 weeks before fair.
- Market pheasant/chukars/quail are shown as a pen of three and must consist of one male and two females or two males and one female.
- Market pheasant/chukars/quail is offered to buyers during the auction “for release only.” Youth and buyers agree on a time and place to meet for the release of birds.
- Market birds must be released within two (2) weeks of the conclusion of the fair.
- No weight requirement for pheasants/chukars.

Livestock Barn Rules

- No sleeping in the barn.
- No open-toed footwear is allowed in animal pens, stalls, or alleyway when handling/working with animals. • Alleyways, stalls, and pens must be kept clean at all times.
- The Fair Board, with the recommendation of superintendents, will decide appropriate bedding for animals. Youth will be required to purchase and use the bedding deemed appropriate.
- Exhibitors are strongly encouraged to post a thank you and buyers name above all market animals by noon on Friday following the auction.
- All animals in the barn must be checked for food and water at approximately 10am and 8pm. The barn superintendent will use the following as guidelines to enforce this policy:
 - I: First Warning: Exhibitor verbally notified by superintendent
 - II: Second Warning: Cage will be tagged, and the Fair Board will take action.
- The barn will be cleaned each day by 10am. Exhibitors are responsible for keeping their pens and the barn clean throughout the day. The barn superintendent will use the following as guidelines to enforce this policy:
 - I: First Warning: Exhibitor verbally notified by superintendent.
 - II: Second Warning: Cage will be tagged, and the Fair Board will take action.
- Fees for pens left dirty at the end of fair week will be fined \$25.00 for small animals and \$75.00 for large animals. Checks will be made payable to "Bay County Fair and Youth Exposition".
- All animals must be removed by 9am Sunday, and the barn cleaned by the date and time designated by the Fair Board. Exhibitors will be required to sign-in and sign-out of barn clean-up at the closing of the fair. This is mandatory for all exhibitors with an animal housed in the barn.
- Upon decorating, the exhibitor's name must be on the cage.
- All animals in the barn must be a registered fair entry.
- All feed must be stored neatly in an appropriate, sealed container in a designated area. • All food and water dishes must be appropriate to suit the animal so as not to be tipped over. Hay bags are optional, if used they must be hung in a safe manner. The bottom of the hay bag must not be lower than the point of shoulders.
- All exhibitors will have a pen limitation of no more than eight (8) livestock pens at the fair. Pens of three animals count as one pen.
- Large animals may only be removed from the stall with an adult's supervision. Traffic areas must be blocked off when doing so to keep the public safe.
- Animals must be washed in the designated area at the back center of the barn. You MUST clean up after your animal once you are done washing.
- For the safety of your animal and passing spectators, stall doors shall be closed at all times, except when entering and exiting the stall/pen.
- If you are aware of a violation of any of these rules please contact the barn superintendent.

POLICIES PERTAINING TO ALL EQUINE

- All equine must meet all current USDA (United States Department of Agriculture) and MDARD (Michigan Department of Agriculture and Rural Development) testing prior to admission in the horse barn. A current negative EIA test (Coggins) is required for any equine species exhibited. A copy of negative Coggins test for animal entered must be attached to the fair entry form or emailed/given to the Superintendent PRIOR to fair registration deadline. Any exhibitor of an equine that does not have the correct Coggins test on file with the fair office will bear the sole responsibility of any fines assessed by MDARD.
- Proof of vaccines are not required but having them done is HIGHLY recommended.
- All animals in the barn must be a registered fair entry.
- An entry form must be submitted for each equine and rider combination.
- The age of equines will be computed from January 1 of the current fair year.
- Equine must be inspected by the Fairboard Superintendent or designated representative upon unloading.
- All exhibits brought to the fair must be clean, of appropriate body condition, free of disease/parasites and uninjured. Any animals deemed sick, injured or unsafe will be sent home under Superintendent/Vet discretion.
- Should an animal become lame, sick, or die prior to judging, the exhibitor may obtain permission from the superintendent to substitute another animal. That animal must have a current Coggins.
- During the Fair, no drugs may be administered to any animal without consent of the superintendent.
- All entries will be judged using the Danish System (A-B-C) and receive corresponding ribbon. When there is only one entry in a class, first place premium money will be paid only if the animal is deemed worthy.
- Any exhibits removed from the fairgrounds before the designated release time (Sat @ 10pm) without permission of the superintendent will result in the revocation of premiums. Exceptions can be made on a case-to-case basis. Those exceptions MUST be communicated to the superintendent PRIOR to fair arrival to be approved.
- Stallions over the age of 1yr old are not eligible to be shown by any Youth exhibitors.
- Stall assignments will be determined by the Superintendent and tack stalls will only be given if there are extra stalls after horses are assigned. Youth is the priority.

Horse Barn Rules

- Upon decorating, no staples, nails, tacks etc. must be used on the stalls, but can be used on the white painted and rafter area of the "old" barn.
- Anyone under the age of 18 MUST wear a helmet at all times when riding a horse. No riding in the barns at any time.
- Barns & arenas will be closed at 11 p.m. with lights out.
- No dogs or bikes permitted in the barn.
- No open-toed footwear is allowed in stalls, or alleyways when handling/working with animals.
- No excessive whipping, spurring or racing. No running of horses outside of arenas is permitted.
- No tying horses to stall fronts.
- The barn will be cleaned each day by 10am. **Exhibitors are responsible for keeping their pens and the barn clean throughout the day.** The barn superintendent will use the following as guidelines to enforce this policy:
 - I: First Warning: Exhibitor verbally notified by superintendent.
 - II: Second Warning: Stall will be tagged, and the Fair Board will take action.
- All food and water dishes must be appropriate to suit the animal so as not to be tipped over or to put the animal in danger (foot caught). Hay bags are optional, if used they must be hung in a safe manner. **The bottom of the hay bag/water buckets must not be lower than the point of shoulders.**
- Horses may not be removed from stalls by anyone but the animal's owner or exhibitor unless given permission.
- Animals to be washed must be washed in the designated area at the west end of the barn. You MUST clean the wash rack after each use.

- No horses are permitted in the camping areas.
- All Youth exhibitors showing an animal must attend at least one pre-fair set-up event. A few dates will be given at Fair Entry Registration each year.
- All animals must be removed by the date and time designated by the Fair Board (Sat 10pm/Sunday 2pm). This is mandatory for all exhibitors with an animal housed in the barn.
- We ask that all stall decorations stay up until haul out time begins (Sat 10pm). Your stalls and decorations are YOUR responsibility to clean.
- Horse Barn Clean Up Process will be as follows: **(NEW FOR 2025)**
 - You will haul out at the designated time(s)
 - Decorations removed and disposed of.
 - Stall(s) to be stripped and swept. All shavings will need to be dumped in the manure bunker.
 - Buckets of bleach/water will be available and poop stains must be scrubbed.
 - Isel way in front of stall(s) swept clean as well.
 - Stall(s) will be inspected by the Superintendent and upon approval you will be free to leave.
 - There is no need to come back on Sunday if you haul out and clean Saturday UNLESS you have Livestock then you will have to help with Livestock barn cleanup as well.
- Fees for stalls left dirty at the end of fair week will be fined \$75.00. Checks will be made payable to "Bay County Fair and Youth Exposition".
- If you are aware of a violation of any of these rules, please contact the barn superintendent.

POLICIES PERTAINING TO ALL STILL PROJECTS

- Judging will take place in-person at the Merchants Building. Dates and Times will be announced each year.
- Projects limited to 25 entries per exhibitor.
- All exhibits must be the work of the exhibitor and have been completed during the time from the end of last year's fair until the present fair.
- Entries will not be accepted or changed after the registration deadline.
- Each exhibitor must securely attach a completed exhibitor's tag to their entries, or they will not be judged.
- All projects must be shown by the exhibitor that entered the project unless prior arrangements have been made with the Fairboard Superintendent.
- Only youth exhibiting, superintendents, and volunteers guiding youth will be allowed in Merchant's Building during judging.
- Any youth exhibiting must be in line 15 minutes prior to the end of posted judging time.
- Each club or youth can decorate an area in the Canteen for their projects to be displayed after judging.
- After the youth has all of their projects judged, please take them to the Canteen for display (with their club, if applicable).
- If the youth receives an Outstanding ribbon, please secure the ribbon to the project, and place the project on the Outstanding Exhibits table in the Canteen. Judges will review all Outstanding projects for consideration of high honors.
- If showing ONLY Still Projects, barn clean ups are not required. ONLY Volunteer Time is required.
- Projects and any decorations will need to be picked up and area cleaned on the Sunday following the close of the fair. The Canteen will be open 8:00 am - 12:00 pm for project pick-up and clean-up.
- When disposing of projects, please take them to the dumpster on the west side of the Canteen.
- Any projects not picked up by 12:00 pm will be disposed of.
- Exhibitors are responsible for cleaning up their Canteen area after the fair, including sweeping the floor and putting away the tables used.
