Track it Using online tracking is one of the easiest and most convenient ways to keep an eye on any shipment. Most websites even include a specified time of drop off rather than just the day and will also notify you of any delays or if the item is being held at a local facility for pickup.

- 2. Ask a Friend If you know you'll either be out of the house or on vacation at the time of a scheduled delivery see if a neighbor or friend can either pick it up and hold it for you or put it in a designated hiding spot.
- 3. Leave a Note One of the oldest tricks in the book is to simply leave a note for the delivery man with instructions to either hide it somewhere specific or even leave it at a neighbor's house.
- 4. Require a Signature Requiring a signature guarantees nothing will be left out in the open; the delivery man will leave a note saying they attempted to deliver so that you can choose whether to have them try again or pick it up from the specified location.
- **6. Add Some Décor** If the package can be clearly seen from the road or sidewalk it's especially vulnerable. By adding chairs, plants or an outdoor storage bench to place packages inside, it provides less of an opportunity for any packages to be seen and taken.
- 7. Don't Make it a Surprise If you plan on sending any gifts or boxes let the person you are sending it to know it's coming so they can also plan ahead. Providing the receiver with the actual tracking information is also convenient.
- **8. Send it to the Locker** Amazon Locker, it's a fairly new concept from Amazon that allows you to pick up your packages at one of their locker locations. When ordering on Amazon just select the delivery to a nearby locker location.
- 9. Add a Wi-Fi Camera If you have security cameras at home or have been having problems with package thieves, setting up a camera like one of <u>D-Link's Wi-Fi Cameras</u> facing your door or walkway can help track any deliveries or activity. You can view the live feed anywhere with the mydlink app or record the feed using a micro SD card.
- Post a Warning Sign Signs for security systems can be a great deterrent for thieves.
- 11. Pick it up at your local Post Office, FedEx, or UPS. They all offer a service to hold your package at their facility.
- 12. Deliver to your workplace UPS, USPS, and FedEx all deliver to business ad-
