DEPOSIT/ PAYMENT

In order to secure a seat on the trip, the following payment schedule has been established:

- An initial full deposit of \$250.00 per person is due on or before September 6, 2019. *Please note, partial deposits will not be accepted.*
- A second payment of \$225.00 per person is due on or before October 4, 2019.
- A third payment of \$225.00 per person is due on or before November 1, 2019.
- A fourth payment of \$225.00 per person is due on or before January 7, 2020.
- Final payment or the balance of the trip (\$225.00 Student Quad / \$725.00 Adult Single / \$425.00 Adult Twin / \$300.00 Adult Triple / \$225.00 Adult Quad) is due no later than February 4, 2020.
- All checks, cashiers checks or money orders should be made payable to Thomas Tours and mailed directly with an enclosed reservation/payment form to Thomas Tours, 2405 12th Avenue South, Nashville, TN 37204-2415. CANCELLATION POLICY
