### **ASSUMPTION OF RISKS**

I, the Releasor, am aware that renting, erecting, and making use of the inflatable rental units from the Releasees exposes me to risks, dangers and hazards to which I might not otherwise be exposed if I did not participate in such activities. Such risks, dangers and hazards include, but are not limited to, personal injury, disability, death and/or damages to my personal assets and possessions.

### **RELEASE OF LIABILITY**

In consideration of the Releasees' provision of inflatable rental units and the Releasees' permission to erect and make use of such inflatable rental units, in consideration of the sum of 225 DOLLARS (\$225.00) now paid by the Releasor to the Releasees, receipt and adequacy of which is by the Releasor hereby acknowledged, I, the Releasor, hereby agree as follows:

**1. TO WAIVE ANY AND ALL CLAIMS** that I have or may in the future have against the RELEASEES, and **TO RELEASE THE RELEASEES** from any and all liability for any loss, damage, injury or expense that I may suffer, that my next of kin or any third party may suffer as a result of or arising in any manner in relation to renting, erecting, and making use of the inflatable rental units from the Releasees, including, without limitation, any damages, injury, or expense due to any cause whatsoever, **INCLUDING, WITHOUT LIMITATION, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE, ON THE PART OF THE RELEASEES;**

2. TO HOLD HARLMESS AND INDEMNIFY THE RELEASEES from any and all liability for any damage to property of or personal injury to, me or any third party, resulting from or arising in any manner in relation to renting, erecting, and making use of the inflatable rental units from the Releasees, including, without limitation, any damages, injury, or expense due to any cause whatsoever, INCLUDING, WITHOUT LIMITATION, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE, ON THE PART OF THE RELEASEES

3. This Agreement shall be effective and binding upon the Releasor's heirs, next of kin, executors, administrators, assigns and legal personal representatives, in the event of the Releasor's death or incapacity;

4. This Agreement shall be governed by and interpreted in accordance with the laws of the Province of British Columbia; and

5. Any litigation involving the parties to this Agreement shall be brought solely within the Province of British Columbia.

In entering into this Agreement the Releasor is not relying upon any oral or written representations or statements made by the Releasees.

**I HAVE READ and UNDERSTAND THIS AGREEMENT and I AM AWARE THAT BY SIGNING THIS AGREEMENT I AM WAIVING CERTAIN LEGAL RIGHTS WHICH I, ANY THIRD PARTY OR MY OR THEIRS HEIRS, NEXT OF KIN, EXECUTORS, ADMINISTRATORS, ASSIGNS AND LEGAL PERSONAL REPRESENTATIVES MAY HAVE AGAINST THE RELEASEES.**
