EIGHTH STATUS REPORT OF GEOFF WINKLER, RECEIVER CAPSOURCE, INC.

Geoff Winkler of American Fiduciary Services, LLC (the "Receiver"), the Court-appointed receiver for defendant CapSource, Inc., submits his Eighth Quarterly Report ("Report") for the period April 1, 2024, through June 30, 2024 ("Reporting Period"), regarding the receivership pursuant to Local Rule 66-4(b).

Defendants.

PRELIMINARY STATEMENT

As reflected in the Court's record and discussed further in this Report, the Receiver has been authorized, empowered, and directed to, among other things: (1) take exclusive authority and control over the Receivership Defendant; (2) conduct such investigation and discovery as necessary to identify and locate outstanding assets of the Receivership Defendants; (3) preserve and prevent the dissipation of such assets.

The Receiver has diligently pursued these goals since August 26, 2022, at the inception of the receivership. As detailed herein, since the entry of the Order Appointing Receiver (the

"Appointment Order") (ECF. No. 17), the Receiver has made substantial progress, particularly in taking possession of CapSource files and inventory and beginning analysis of same; review of investor list and communication with investors; analyze accounting records; communication with defendants; evaluating assets and properties of the estate; assessment of income and investor payment options; evaluating and terminating a lease; analysis of ancillary proceedings and communication with counsel; processing account information; evaluating estate needs including tax issues; preparation of financial and quarterly reports; communication with SEC regarding pending matters; and preparation of stipulations and court filings. However, because the Receiver's work is ongoing, the conclusions presented herein are preliminary and subject to modification or supplementation as more information becomes available.

As of the date of this Report, the Receiver has not completed an investigation or accounting of principal reduction loans, however active loans have been reviewed for the purpose of interim distributions.

II. SUMMARY OF THE RECEIVER'S OPERATIONS (LR 66-4(b)(1))

A. THE RECEIVER'S INVESTIGATIVE AND MARSHALLING ACTIVITIES

The Receiver and his counsel continued to work through legal proceedings involving CapSource, all of which are currently stayed or dismissed. None of these legal proceedings were previously disclosed to the Receiver in his capacity as either Receiver or CRO. Additional information on this matter can be found in section V, subsection A.

During this reporting period the Receiver made his third distribution under the Order Granting Receiver's Motion for Approval of 1) Interim Distribution Plan; and 2) Procedures for Disposition of the Estate's Interests in Certain Real Property filed August 2, 2023. The Receiver distributed \$90,119.99 across 2 outstanding loans and 360 investors, although not all checks have cleared. The Receiver and his team are working with the individuals with returned checks or similar distribution questions. The Receiver has reissued checks for individuals he has communicated with who didn't receive their distribution. The Receiver will continue to make distributions quarterly when funds allow, in accordance with the distribution order.

Per investor requests, the Receiver and his team have continued to investigate investments and other outstanding loans that are not included in the list of outstanding note receivables below. Investors continue to provide additional information and the Receiver is reviewing additional documentation provided by CapSource. The Receiver will inform the court of his findings on this investigation in future reporting periods.

The Receiver successfully secured \$1,356,122 in cash during this reporting period. A description of all assets in the custody and control of the Receiver is included in Section III, below.

В. INVESTOR AND CREDITOR COMMUNICATION

The Receiver has continued to update the investor website (http://www.capsourcereceivership.com). The Receiver and his team have continued to review registration forms directly from investors and invite investors who have not done so yet, to do so at their earliest convenience (http://www.capsource-receivership.com/register). The investor list as of June 30, 2024, had approximately 637 individuals.

C. THE RECEIVER'S FORENSIC ACCOUNTING ACTIVITIES

In a previous reporting period, the Receiver and his team received information from WestStar to review outstanding loans and created a money-in money-out (MIMO) analysis for each of the investors. This analysis was completed and included all loan transactions for the outstanding loans and principal reduction loans. The Receiver anticipates the principal reduction loan analysis will be complete in a future reporting period.

III. INVENTORY OF ASSETS AND ESTIMATED VALUE (LR 66-4(b)(2))

CASH \boldsymbol{A} .

From April 1, 2024, to June 30, 2024, the Receiver was able to recover approximately \$1,356,122. The Standardized Fund Accounting Report for the period is attached to this report as **Exhibit A.** This cash is made up of \$4,528 from interest received on money held in the receivership estate bank account and \$1,351,594 in business income.

The Receiver invites the Court and all interested parties to review the First Status Report (ECF No. 21) for a general summary of the relevant information for each of the outstanding notes listed below. The following information will include the most recent updates that have transpired.

A. Texas 156

As stated in previous reports, the Receiver has been presented with an offer from the borrower for the remaining four lots. In this Reporting Period, the Receiver worked with the buyer to investigate the outstanding liens associated with one of the remaining lots. The Receiver believes ten investors are due payments to recover their principal. Investors not included in this recovery will have the opportunity to file a claim.

B. 5th Avenue Estates

As discussed in a prior status report (ECF No. 28), the last parcel for 5th Avenue Estates was sold on October 26, 2022, and proceeds were received by the Receivership Estate on October 27, 2022. During the previous Reporting Period, distributions were made per Order (ECF No. 61) up to 100% of principal investment.

C. King 261 and Meadows 78

Investors with King 261 received an interim distribution during a previous reporting period. King 261 and Meadows 78 were sold in this reporting period. The Court ordered on May 3, 2024 that the stipulation authorizing the sale be granted. The Receiver will be distributing the proceeds from the sale in accordance with the Order (ECF No. 61) in the following reporting period.

D. Fillmore Real Estate Partners

The Receiver anticipates a compromise of the note associated with Fillmore Real Estate Partners. As stated in previous reports, the Receiver has been presented with an offer from the borrower. The Receiver has let the borrower know of the order allowing the sale of the receivership estate's interest in the first deed of trust. In the Reporting Period, the borrower reviewed and continued to add language to the Purchase and Sale Agreement. The borrower and the Receiver have come to an agreement, and the Purchase and Sale Agreement will be executed in the following reporting period.

E. JC Commercial

The JC Commercial property was sold in this reporting period. The Court ordered on June 6, 2024 that the stipulation authorizing the sale be granted. The Receiver will be distributing the proceeds from the sale in accordance with the Order (ECF No. 61) in the following reporting period.

F. ARC RE

A settlement was reached between the SEC and ARC RE that was approved on June 29, 2024 (Securities and Exchange Commission v. America's Rehab Campuses, LLC, U.S. District Court for the District of Nevada, Case No. 2:20-cv-02308-JCM-DJA). The Receiver was appointed as the Distribution Trustee for the purpose of distributing the settlement funds to the CapSource

ARC Option 3 and ARC Reg D investors on June 29, 2023 (ECF No. 59). The CapSource Receiver, in his role as Distribution Trustee, distributed \$3,243,170.90 at the end of the reporting period. This is relevant to the CapSource receivership as it will influence Option 3 investors, who received distributions and consequently will reduce their principal amount within the CapSource receivership. Future interest will be affected by this smaller principle. The Receiver and his team continue to meet with ARC's consultant, counsel, and CEO. Details of this period's meetings are below.

In the last reporting period, ARC was in the middle of an industry audit being conducted by the State of Arizona. Other facilities had previously concluded their audit and ARC was one of the last due to the size of the company. The audit has concluded, and the borrower is able to move forward with servicing patients. However, the audit led to a cash constraint and ARC reached out to the Receiver to discuss short-term postponement of monthly interest payments.

In addition to the above activities, Option 3 investors with ARC RE received an interim distribution as discussed above.

insiders who benefitted unjustly from CapSource's unlawful activity. In previous reports, the Receiver separately noted that it might be appropriate for the Receiver to initiate litigation against certain third parties. During the reporting period, the Receiver dedicated resources to investigating at least three different potential third-party causes of action discovered over the course of the Receivership. Investigation continues, but the Receiver anticipates issuing demand letters during the third quarter of 2024 or otherwise taking action on the potential claims he has identified in connection with the investigations.

VI. RECOMMENDATION OF THE RECEIVER (LR 66-4(b)(5))

At this juncture, the Receiver has evaluated the outstanding loans and identified the investors related to these loans. The Receiver recommends that the receivership continues to identify assets and claims and pursue them for the benefit of the Receivership Estate, and he will continue to evaluate loans that received principal reductions.

Additionally, if the Court would like an opportunity to canvas the Receiver, the Receiver requests that the Court promptly set an in-person or virtual hearing under Local Rules 66-4(b) and/or 66-5. See LR 66-4(b) and 66-5 (governing proceedings related to the activities of courtappointed Receivers). The Receiver and his counsel will endeavor to make themselves available for any date(s) the Court proposes on fourteen days' notice, as contemplated by Local Rules 66-4(b) and 66-5, or less, as the Court may order. See id.

VII. **CONCLUSION AND REQUESTED RELIEF**

Assuming the Court authorizes the Receiver to undertake the actions recommended herein, as well as to continue those actions provided for in the Appointment Order, any amendments thereto and any subsequent orders, the Receiver proposes to submit further interim reports to this Court, addressing his progress, findings, final conclusions, and additional recommendations, approximately every 90 days. Accordingly, and based on the foregoing, the Receiver respectfully requests that the Court set a hearing and/or enter an order:

- 1. Accepting this Eighth Status Report;
- Authorizing the Receiver to continue to administer the Receivership Entities and 2. their estate in accordance with the terms of the Appointment Order;
