DEAR GRAND MASTERS AND DIGNITIES,

RECEIVE A FRATERNAL GREETING. WE ARE WRITING TO YOU ON BEHALF OF THE COORDINATING COMMITTEE OF CONFERENCE OF THE WORLD MASONIC FRATERNITY TO INVITE YOU TO PARTICIPATE IN THE INTERNATIONAL ECOLOGICAL MASONIC DAY. AN INITIATIVE ARISING FROM THE AGREEMENTS REACHED AT THE WORLD CONFERENCE OF THE MASONIC FRATERNITY, HELD IN MEDELLÍN IN JULY 2024. THIS CONFERENCE IS ALSO PART OF THE FINAL DOCUMENT OF THE FORUM THAT HAS BEEN PRESENTED TO THE OFFICE OF THE SECRETARY-GENERAL OF THE UNITED NATIONS, THUS CONSOLIDATING OUR COMMITMENT TO THE PROTECTION OF THE ENVIRONMENT AND GLOBAL WELL-BEING.

DETAILS OF THE INTERNATIONAL ECOLOGICAL MASONIC DAY

DATES OF THE DAY: EACH GRAND LODGE THAT DECIDES TO PARTICIPATE WILL BE ABLE TO CARRY OUT ITS ACTIVITY ON NOVEMBER 30 OR DECEMBER 1, 2024, DEPENDING ON WHAT THEY CONSIDER MOST APPROPRIATE.

CONCRETE ACTIONS: PARTICIPATING GRAND LODGES WILL BE FREE TO CHOOSE ONE OR MORE OF THE FOLLOWING ACTIVITIES:

TREE PLANTING: WE WILL ARRANGE TREE PLANTINGS, AND EACH GRAND LODGE WILL ARRANGE FOR THE NECESSARY PERMITS BASED ON LOCAL REGULATIONS, AS WELL AS THE SELECTION OF TREE SPECIES APPROPRIATE TO THEIR REGION.

CLEANING OF GREEN SPACES: A CLEANING DAY MAY BE CARRIED OUT IN PARKS, SQUARES OR OTHER NATURAL AREAS.

ECOLOGICAL TALKS: THEY MAY ORGANIZE CONFERENCES, SEMINARS OR EDUCATIONAL TALKS ON ECOLOGY AND ENVIRONMENTAL CONSERVATION.

LOCAL ORGANIZATION: EACH GRAND LODGE WILL BE RESPONSIBLE FOR COORDINATING THE OPERATIONAL DETAILS OF THE CHOSEN ACTIVITY. WE ENCOURAGE YOU TO USE YOUR OWN RESOURCES TO CARRY OUT THESE ACTIVITIES AND TO APPLY FOR THE NECESSARY LOCAL PERMITS IN CASE OF PLANTING TREES.

GLOBAL REACH: OUR GOAL IS FOR THIS DAY TO BE HELD IN AT LEAST 20 DIFFERENT CITIES AROUND THE WORLD, WITH THE PARTICIPATION OF MASONS AND THEIR FAMILIES.

ALL ATTENDEES MUST WEAR A WHITE T-SHIRT WITH THE ECOLOGICAL LOGO APPROVED AT THE MEDELLÍN CONFERENCE, ENGRAVED ON THE SIDE OF THE HEART. THIS LOGO MAY ALSO BE PRINTED ON BANNERS TO ACCOMPANY THE ACTIVITIES.

PRINT SIZE: IT MUST BE ACCORDING TO THE SIZE OF THE T-SHIRT. A "IOCM" DIAMETER LOGO IS STIPULATED AS A BASE FOR A SIZE "S" T-SHIRT. IF THE T-SHIRT IS LARGER, THE DIAMETER OF THE LOGO PROGRESSIVELY INCREASES BY "ICM".

POWER PRINT: THIS MUST BE WITH ARCHED LETTERS, AS IT APPEARS IN THE INSTRUCTION IMAGE, IT MUST MENTION EXACTLY THE SAME AS THE INSTRUCTION IMAGE INDICATES. THE FONT CAN VARY.

GENERAL INSTRUCTIONS:

- 1)- T-SHIRT TYPE: ROUND NECK
- 2)- T-SHIRT COLOR: WHITE.
- 3)- TEXTILE COMPOSITION: COTTON AND ALL DERIVATIVES OF COTTON-BASED TEXTILE COMPOSITIONS.
- 4)- CHEMICAL COMPOSITION OF THE PRINT: NOT DEFINED, DEPENDING ON THE COUNTRY WHERE YOU ARE LOCATED.
- 5)- LOCATION OF THE FRONT PRINT: LEFT SIDE OF THE T-SHIRT, EXACTLY ON THE LEFT CHEST.
- 6)- Type of print: Heart stitch on the left side.
- 7)- LOCATION OF THE REAR PRINT: LETTERS OF THE WORD "ENVIRONMENT" LARGER THAN THE LOWER ONES. ARC SHAPE OF THE WORD "ENVIRONMENT". ARC SHAPE OF THE WORD "ECOLOGY". NORMAL TEXT, OF THE WORD "C:.M:.F:.M:.".
