

SAFETY RULES & REGULATIONS

NO LOADED FIREARMS, NO ALCOHOLIC BEVERAGES, NO BLACK POWDER.
If you are observed to be under the influence of drugs or alcohol you will be asked to leave the event.

NO VIDEO OR PHOTOS, THIS INCLUDES CELL PHONE CAMERAS. NO EXCEPTIONS!

LOADED FIREARMS ARE NOT PERMITTED ON THE GUN SHOW PREMISES. EXHIBITORS AND PATRONS ARE REQUIRED TO EXAMINE EACH FIREARM, REMOVE MAGAZINES AND BE POSITIVE THAT THE FIREARM IS NOT LOADED BEFORE ENTERING THE GUN SHOW PREMISES. ALL GUNS MUST BE SECURED FROM THEFT BY TIES THROUGH THE TRIGGER GUARD OR PLACED IN SHOWCASES.

EXHIBITORS AND PATRONS MUST COMPLY WITH ALL LOCAL, STATE, AND FEDERAL LAWS.

ALL CLASS III ITEMS MUST HAVE APPROPRIATE PAPER WORK WITH THEM.

GUN SHOW SECURITY IS PROVIDED BY LOCAL POLICE IN UNIFORM AND PLAIN CLOTHES, BUT THEY CANNOT BE EVERYWHERE. POLICE YOUR OWN TABLES TO PROTECT YOURSELF FROM THEFT. REQUIRE PROPER IDENTIFICATION WHEN SELLING FIREARMS, AMMO, OR WEAPONS TO DETERMINE AGE AND IDENTITY. YOU MUST BE 21 YEARS OLD TO BUY A HANDGUN OR HANDGUN AMMO. MINORS ARE NOT PERMITTED IN THE SHOW WITHOUT PARENTS. IF YOU SEE MINORS WITHOUT PARENTS, REPORT THEM TO SECURITY.

NO EXPLOSIVES ARE PERMITTED OTHER THAN SMALL ARMS AMMO, GUN POWDER AND PRIMERS IN SEALED CONTAINERS. NO GRENADES, ROCKETS, BOMBS, GAS SHELLS OR GAS IN SMALL ARMS IS PERMITTED ON THE GUN SHOW PREMISE.

NO TABLE RENT REFUNDS IF CANCELLATION IS RECEIVED WITHIN 10 DAYS OF SHOW. TABLES WILL NOT BE HELD WITHOUT PAYMENT. IF CANCELLATION IS RECEIVED BEFORE THE 10 DAY WINDOW A 50% REFUND WILL BE GIVEN AS A CREDIT ON FUTURE BOOKINGS. EXHIBITORS SHOULD PLAN ON STAYING UNTIL SHOW CLOSES EACH DAY. THIS IS REQUIRED. EARLY CLOSING WILL RESULT IN A \$50 FEE ON YOUR NEXT BOOKING-

THE GUN SHOW PROMOTER ACCEPTS NO RESPONSIBILITY OR LIABILITY FOR ANY AND ALL DAMAGES OR INJURIES RESULTING FROM AN EXHIBITOR'S OR PATRON'S DISPLAY OR ACTIONS. EXHIBITORS AND PATRONS HEREBY ASSUME FULL LIABILITY FOR ANY AND ALL DAMAGES OR PERSONAL INJURIES RESULTING FROM THE USE OF ANY ITEM OF THE EXHIBITOR OR PATRON AND WILL HOLD HARMLESS THE GUN SHOW PROMOTER. THE GUN SHOW PROMOTER RESERVES THE RIGHT TO REFUSE ADMISSION TO ANYONE. VIOLATION OF THESE RULES BY A PATRON OR EXHIBITOR MAY RESULT WITH YOU BEING REQUESTED TO LEAVE THE GUN SHOW.

BY COMPLETING THE RESERVATION FORM, I ACKNOWLEDGE THAT I HAVE READ THE SAFETY RULES AND REGULATIONS AND AGREE TO DISPLAY MY ITEMS AS LISTED. I FURTHER AGREE TO RELEASE THE GUN SHOW PROMOTER FROM ALL LIABILITY FOR ANY THEFT, DAMAGES, LOSSES, OR INJURIES I MAY SUFFER WHILE ON THE GUN SHOW PREMISES.

Important Notice to Exhibitors and Individuals Selling or Buying at this Show

Double check all guns to make sure they are not loaded. Open the action before examining any gun.

Exhibitors and patrons at this show must obey all local, state, city and Federal laws.

Licensed dealers must display their licenses as per ATF regulations. All guns must be secured from theft by tying together or in showcases. Sales of guns, knives, ammo, or weapons to minors are prohibited. You must be 21 years old to buy a handgun and a resident of Ohio. You must also be 21 years old to buy handgun ammo. You must require photo ID when selling any firearm. If you sell to a minor or felon, you may be arrested, convicted of a crime and sent to prison.

If you see minors in the show without parents, report them to a police officer at the show entrance.
or event security-

24-hour security provided by local police in uniform and plain clothes. Several officers will be on duty, but they cannot be everywhere. Police your own tables at all times. If a gun or knife is stolen from you, you may be guilty of negligence, sued and be required to pay damages. Tie your guns down.

Be aware that you may be asked to make an illegal sale by a TV or newspaper reporter, felon, minor, or ATF agent. Several dealers have been set up like this at other area shows. Obey the law and require proper ID or you may be sued or convicted of a crime. ATF and police are at every show. You must require a photo ID when selling firearms.

ATF states non-licensed residents of Ohio may acquire from and dispose of personal firearms to non-licensed residents of Ohio. Non-licensed residents of Ohio cannot acquire from or dispose of firearms to non-licensed residents of any other state. If you are not sure of how many guns you may buy or sell, contact your local ATF office.

As set forth on the attached ATF "Gun Show Guidelines", any seller holding a federal firearms license is required to follow the exact same set of laws and regulations when doing business at a gun show that they must follow when doing business at their store -- including FBI background checks on ALL firearms transactions.

A private party who does not hold a federal firearms license, however, is not required by state or federal law to conduct a FBI background check when selling a firearm to another private party (Nor is it even possible for non-licensee, private parties to conduct FBI background checks, because such are only available to those holding a federal firearms license) Accordingly, non-licensed, private parties may sell firearms at gun shows in accordance with state and federal law, as long as such sales otherwise fully comply with all provisions of federal and other applicable law (i.e., they cannot transfer guns to people they know or have reason to believe are prohibited from possessing the guns such as felons, illegal aliens, mental defectives, etc.). This is the Federal law throughout United States, and it applies to all private sales regardless whether they occur at gun shows, a private residence, or anywhere elsewhere.

Accordingly, to the extent that anyone engages in conduct as a buyer or a seller of a firearm, whether at a gun show or anywhere else, that is in any way in violation of any applicable law, they will be prosecuted to the fullest extent of the law.

**NON-RESIDENTS: CAN NOT BUY, SELL OR TRADE FIREARMS TO PRIVATE INDIVIDUALS.
YOU MAY SELL FIREARMS TO ANY FFL DEALER, REGARDLESS OF THEIR RESIDENCY.
YOU MAY BUY LONG GUNS FROM A FFL DEALER WHO IS LICENSED IN THE SAME
STATE, PROVIDED THE LAWS OF BOTH STATES ARE COMPLIED WITH.**

**RESIDENTS: MAY SELL, BUY, TRADE FROM ANYONE WHO IS ALSO A RESIDENT. YOU
CAN NOT BUY, SELL OR TRADE WITH ANYONE WHO IS NOT A RESIDENT. YOU MAY SELL
FIREARMS TO ANY FFL LICENSE DEALER, REGARDLESS OF THEIR RESIDENCY.**

You must be 18 or over to enter or be accompanied by a parent or a legal guardian. You must be 21 or older to purchase, sell or handle a handgun and 18 or older to purchase, sell or handle a rifle or shotgun. No exceptions. Class 3 Items must be accompanied with proper documentation.

No video or photos inside the event venue. This includes cell phones. Anyone found to be taking video or still photos will be asked to leave the event.
