# REGISTRATION NEWS

December is the month that we begin registration for next September's admissions. You have received an "intent to return" form earlier this month. If you intend for your child to be a part of our program next year, it is imperative that you fill out the form and return it by the December 19th deadline listed on the form. This will be your ONLY guarantee of a space in our classes next year. Your request will be honored on a first-come first-served basis. Open public enrollment will begin on January 5th, and our classes will be filled on a first-come, first-served basis. Please note: if your child is currently enrolled in our program, there is NO registration fee for a second year, unless your child is age-eligible for kindergarten, but returning to Heaven Sent for one more year. (If you have a child who IS age-eligible for kindergarten, please see Mrs. Marsh for information about the registration fee for those students.) We will also accept enrollment of siblings this month, which is due December 19<sup>th</sup>.



If you have a younger child whom you would like to enroll in Heaven Sent for our 2.5, 3 year old or 4 year old classes, please see Mrs. Marsh to fill out a sibling intent form. We will keep it on file until December of the year preceding his/her entry into our program. We currently have a file for siblings who will not be enrolling until September 2027, so it is never too early to sign up!
