PURPOSE: The Loving County Commissioners Court will discuss and take possible action regarding a tax abatement agreement with MarkWest Energy West Texas Gas Company, LLC pursuant to Chapter 312 of the Texas Tax Code.

Applicant (“Applicant”) for Tax Abatement: MarkWest Energy West Texas Gas Company, LLC

Proposed Reinvestment Zone: MarkWest Energy Reinvestment Zone

Property in Proposed Reinvestment Zone: See attached map and property description provided in Exhibit “A” attached hereto and incorporated herein for all purposes.

Anticipated Improvements: The general description of the nature of the improvements included in the agreement is as follows:

Applicant anticipates constructing up to a 300MMcf/d cryogenic gas processing plant and associated pipelines. Improvements may include (but are not limited to) slug catchers, condensate stabilizer system, inlet treater, separators, filters, amine treatment facilities, dehydration, cryogenic gas plant, refrigeration system, compressors, heaters, thermal oxidizer, flare system, and in-plant roads.

Estimated Cost of the Anticipated Improvements: The estimated cost of the Anticipated Improvements in Loving County being contemplated by Applicant is approximately \$300,000,000.00.


