2. Endorsement of the 8th Congressional District, U.S. House Candidate

3. Electing 3 CD8 Delegates and 3 CD8 Alternates to the RNC Convention
  - a. Candidates for the National Delegates and Alternates to the RNC must register with the MNGOP by March 31st to be considered.

4. Electing a Presidential Elector-Nominee and an Alternate for the 8th Congressional District
