**Make Government Smaller and Better**

**I move that this precinct caucus support the following change to the above plank:**

We oppose electronic and NGO (Non-Government Organization) involvement in election processes and reporting.

We support locally stored Election Judges' personal data; we do not support NGO access to Election Judges' personal data. We support paper ballots to hand-mark selections on the ballot. We support hand-counting of votes for all races that involve more than one candidate and on all referendums on the ballots. We support paper-only poll books. We do not support electronic tabulators or electronic poll pads.

**This position is supported for the following reasons.**

- The majority of people do not trust the elections and their reported results.
- There is a growing trend to turn control of election processes and reporting over to organizations that are outside of government. These Non-Government Organizations (NGO's) are not subject to Freedom of Information Act (FOIA) requests.
- The current process includes external electronic communication access to the precinct elections by way of the Electronic poll pads and Electronic Tabulators. All external electronic communication to the precinct needs to be eliminated.
- We The People not only have the right to vote, but we also have the right to understand, observe, and participate in the process of counting votes and validating vote counts reported.
- These changes will make elections more secure, transparent, and trustworthy for and to the public.
- These measures ensure local control and management to more closely ensure integrity in process and execution.

**I move that this precinct caucus support the following change to the above plank:**

We support local control of election data and processes through: city-established precincts of <2,000 registered voters and corresponding polling locations; city management of election judge hiring, training, scheduling, operations, payroll, and associated data; establishment of city-managed Ballot Boards and Election Day hand-counting of races and referendums; city-managed Post Election Reviews (PER) sample for all contested races; and county-only control of their residents' voter information and ballot issuance in the State Voter Registration System.

**This position is supported for the following reasons.**

- The majority of people no longer trust the elections and the reported results.
- Control for election processes and reporting has shifted to higher levels of government or to Non-Government Organizations (NGO's) which are not subject to Freedom of Information Act (FOIA) requests.
- Currently most election contests are not validated after the election with the State mandated PER.
- We The People not only have the right to vote, but we also have the right to understand, observe, and participate in the process of counting votes and validating vote counts reported.
- These changes will make elections more secure, transparent, and trustworthy for and to the public.
- These measures provide local control and management to more closely ensure integrity in process and execution.

Never Again Bill

## Resolution to Pass the "Never Again" Bill

Whereas: The role of the executive branch is to implement and uphold our law, and is expressly denied the ability to assume law-making powers by Article III of the Minnesota Constitution

Whereas: An emergency can only be labeled as such if it has begun and ended with urgency; while a governor has the right to act in times of crisis, he was never given the authority of indefinite extension of these powers

Whereas: The worst regimes of the twentieth century used emergency powers as a trojan horse to introduce despotism, communism, and ideologies of inconceivable horror

Whereas: We have the option now of ceasing this precedent of emergency power abuse before it becomes the new standard, and our legislature is relegated to a position beneath the other branches

Therefore, BE IT RESOLVED: That the Republican party demands that the Minnesota Legislature pass the Never Again bill immediately, regardless of opposition stemming from radically corrupted politicians:

The reason we need to put this essential check on the executive branch:

- Governor Walz enforced the unconstitutional cessation of burials, baptisms, weddings, and other religious services expressly protected in the first Amendment
- We have no guarantee that Walz or other Governors in the future won't likewise refute our God given rights
- Any allowance of unconstitutional behavior creates room for indefinite breaches of our liberties in the future
- The state of Minnesota and its residents suffered untold economic and developmental damage from the mismanagement of a power hungry, willfully negligent, and overextended Governor
- An unchecked loss of liberty now would embolden those that desire to trounce on our freedom for political, financial, or personal gain
- The greater the power delegated to an executive, the greater their ability to abuse these powers or enhance our suffering in proportion to their shortcomings

No Agreement with WHO

Whereas, "executive agreements" not brought before the Senate for approval are still binding on the parties under international law; and

Whereas, according to the US Constitution, Article 2, section 2, a US treaty requires a 2/3 vote by the Senate for consideration and approval; and

Whereas, the so-called World Health Organization "Agreement" under consideration should be considered a "treaty" and not bypass Congress; and

Whereas, former President Obama set the precedent to bypass Congress by unilaterally signing America on to the Paris Agreement on August 29, 2016, a binding international agreement on "climate change";

Whereas, the result of President Biden signing the US on to the WHO agreement would effectively hand US Sovereignty over to the UN and end the First Amendment in the United States, giving the WHO the power to decide what is a public health emergency within the US and what actions would be required as well as enforced to control the WHO-defined public health emergency in the US; then

Therefore, be it resolved that the US Congress prevents President Biden from signing the US on to the World Health Agreement by the US House defunding the World Health Organization; and

Therefore, be it further resolved that the US Senate demand any international agreement involving the World Health Organization or any other international organization to be presented for a vote.

## Resolution To Prohibit Vaccine Mandates In Minnesota

Whereas: Minnesota law states that "individuals have a fundamental right to refuse medical treatment, testing, physical or mental examination, vaccination, participation in experimental procedures and protocols, collection of specimens, and preventative treatment programs."

Whereas: All organizations, both public and private, have no right to infringe on a person's health freedom by compelling an individual to get a vaccine against their will as a condition of employment or in the conduct of commerce.

Whereas: Our government exists to guarantee our liberties, and that the notion that our government should compromise these liberties for the cause of public safety is both dangerous to our freedom and contradictory to the values in which our nation was founded.

Whereas: A vaccine mandate would create severe and irreparable damage to the lives and livelihoods of Minnesotans that have made the personal decision to decline the experimental injections.

Therefore, BE IT RESOLVED, the Republican party of Minnesota demands the passage of the Stop Vaccine Mandates legislation.

The reason to prohibit vaccine mandates in Minnesota:

- The long term effects of Covid19 vaccines are still unknown.
- Powers not expressly granted to the Government are expressly delegated to the states in accordance to the 10th amendment, and there are no provisions in the Constitution as it currently stands about inoculations or disease protocol
- A 700,000-person study from Israel found that those who had experienced prior infections were 27 times less likely to get a second symptomatic covid infection than individuals who were only vaccinated,
- a Cleveland study of health-care workers concluded that "individuals who have had SARS-CoV-2 infection are unlikely to benefit from covid-19 vaccination"
- a Washington University study concluded that "even a mild covid infection resulted in long-lasting immunity."
