## **CALL TO ORDER & WELCOME**

Mayor Stronks welcomed everyone and opened the meeting at 7:04 pm.

Jaden Jackson is not present at 7 PM so the Council decided to go ahead.

Councilman Atchley made a motion to go out of order and to go back to item 1 when the engineer is present. Councilman Mattingly seconded the motion. The motion passed unanimously.

# 1. UNFINISHED / OLD BUSINESS:

Each speaker will be allowed a maximum of 5 minutes unless repeat testimony is requested by the Mayor/Council.

A. AURA Street Project Bid Recommendation – Jaden Jackson Riley Bradshaw is from Keller Associates. The bids for the sidewalk project came in above budget. The difference between the grant received and the bid is \$ 160,000. The Council will send Councilman Mattingly to the Ashton Urban Renewal Agency meeting to see if they have more funding for the project. There is the possibility to do part of the project and then more as funding becomes available. Councilman Mattingly will bring information to the Council for a decision on August 8<sup>th</sup>.

#### 2. BUDGET WORKSHOP:

Each speaker will be allowed a maximum of 5 minutes unless repeat testimony is requested by the Mayor/Council.

A. Budget Workshop - City Clerk Stegelmeier

The Council went over the budget, looking at the larger items first. They talked about insurance and salaries at the pool. They discussed the possibility of a concession at the Visitor Center. A camp host was also discussed. Mayor Stronks brought a proposal for the tennis courts. He does have some funding but the total will be about \$123,000. The Council talked about other funding. Councilman Atchley still feels like there needs to be more for young people. The Council discussed all the funds directing City Clerk Stegelmeier which items should be included. City Clerk Stegelmeier will bring the budget to City Council on August 10<sup>th</sup> for their consideration.

Councilman Atchley made a motion to adjourn. Councilwoman Hansen seconded the motion. The motion passed unanimously.
