CALL TO ORDER & WELCOME

In Attendance: Tom Mattingly, Teresa Hansen, Jerry Funke, Tadd Atchley and John Kaelberer. **Also, in attendance:** City Clerk Stegelmeier, City Attorney Angell, Chief Griffel, Deputy Clerk Warnke

Mayor Mattingly welcomed everyone and opened the meeting at 7 pm.

1. BUDGET DISCUSSION – City Clerk Stegelmeier, Chief Griffel ACTION ITEM

City Clerk Stegelmeier explained that the police were going to order a vehicle this fall because they had enough money to purchase one in their budget. The company cannot deliver one that soon. Chief Griffel explained that the state bid calls for the police car to be built with wiring harnesses, etc. built in and there are no 2020 cars left. A 2021 will not be available to order until February. He had spoken with the Mayor and City Clerk Stegelmeier. City Clerk Stegelmeier explained that tonight the Council would vote to amend the proposed budget to include \$40,000 to cover the cost of the vehicle.

2. PUBLIC HEARINGS:

- A. Reading of Proposed Ordinance 480-20 FY2021 Budget Councilman Atchley read the ordinance into the record.
- B. Public Comment (Each speaker will be allowed a maximum of 3 minutes unless repeat testimony is requested by the Mayor/Council.) Mayor Mattingly opened the public hearing at 7:05pm.

There were no speakers signed in to speak. Mayor Mattingly asked if there was anyone in the audience who would like to comment. There were no public comments. Mayor Mattingly closed the public hearing at 7:06pm.

3. ORDINANCE/RESOLUTION:

A. City of Ashton Ordinance 480-20 – City Budget for Fiscal Year 2021 **ACTION ITEM**

Councilman Atchley made a motion to read the City of Ashton Ordinance 480-20 by title only and dispense with the second and third readings. Councilman Funke seconded the motion. Roll call vote was called. The motion passed unanimously.

Councilman Atchley read the ordinance into the record by title.

Councilman Atchley made a motion to that Ashton City Ordinance 480-20 be approved with the proposed \$40,000 amendment and published. Councilwoman Hansen seconded the motion. Roll call vote was called.

B. City of Ashton Resolution 20-02 – Rate Update 2021 **ACTION ITEM**

Councilman Atchley made a motion to adopt the City of Ashton Resolution 20-2. Councilwoman Funke seconded the motion. Roll call vote was called. The motion passed unanimously.

REGULAR BUSINESS:

Each speaker will be allowed a maximum of 5 minutes unless repeat testimony is requested by the Mayor/Council.

4. Facilities and Scheduling – City Clerk Stegelmeier ACTION ITEM

City Clerk Stegelmeier reported that the pool was up and ready to go. There is not enough staff to be open until Saturday and then it will be open Monday, August 31st through September 5th. Councilman Funke suggested that it be open on Labor Day. City Clerk Stegelmeier will see if it can be staffed for that day. City Clerk Stegelmeier then asked that the City Council come to a meeting on life insurance on Friday the 28th at 9 am. Rudey Ballard will be there to explain the insurance.

Mayor Mattingly said that there are a couple of projects the Council needs to think about. The first, of course, is the restroom at the Ashton City Park. Councilman Funke will be working on that this next fiscal year. Another is getting a meter on the water to fill campers at the Visitor Center. The City also needs to get the ordinance together for the hydrant water and look into either some meters for lease OR a bulk water building. The council agreed and will discuss them more at the next meeting.

5. Executive Session – City Attorney Angell, City Clerk Stegelmeier

I.C. 74-206 Certain City-related matters may need to be discussed confidentially as a matter of law (Acquisition of real property, personnel matters, attorney-client communications) subject to applicable legal requirements, the Council may enter executive session by roll call vote to discuss such matters.

(f) To communicate with legal counsel for the public agency to discuss the legal ramifications of and legal options for pending litigation, or controversies not yet being litigated but imminently likely to be litigated. The mere presence of legal counsel at an executive session does not satisfy this requirement.

Councilman Atchley made a motion to enter executive session. Councilman Kaelberer seconded the motion. Mayor Mattingly called for a roll call vote. Councilman Funke, aye; Councilwoman Hansen, aye; Councilman Atchley, aye; Councilman Kaelberer, aye. The motion passed.

The Council entered Executive Session at 7:31 pm.

Councilman Atchley made a motion to exit Executive Session. Councilman Hansen seconded the motion. The motion passed unanimously.

The Council exited Executive Session at 7:40 pm.
