

# Ashton Police Department

As we move from winter to spring, please be aware the City of Ashton has ordinances for weed abatement. You are required to keep your properties moved to prevent noxious weeds from propagating seed. If you have questions or need help with weed control, contact the Fremont County Extension Agent, they are a great resource and are willing to help.

The city has an ordinance for keeping your property free of refuse as well. This ordinance includes unregistered vehicles, car parts, none operating vehicles including ATVs, snowmobiles, wood and metal debris etc. Unregistered vehicles must be kept covered or in a garage.

I will be sending out violation letters around the end of May to violators. The violator has 15 days to comply with the weed ordinance and refuse ordinance or they may be cited for the violation. I do my best to work with property owners to get them into compliance if there is progress and effort from the property owner.

# Lead & Copper Revision Rule (LCRR)

With the creation of the Lead and Copper Rule (LCR) in 1991, the United States Environmental Protection Agency (USEPA) has continued its work towards eliminating lead contaminates from the Country's drinking water.

In December of 1991, revisions were finalized to the LCR, with detailed inventory guidelines being released in December of 2022. These guidelines provide direction on the creation of a service line inventory that will become a dataset of information that will be continually updated as more information and changes are made to the city's water system. This document will be used to identify

what aspects of our system may contain lead and the timeline for replacing those lines.

The deadline for the creation and publication of this document is October of 2024.

The City of Ashton routinely tests for several contaminates that may affect the drinking water quality. Testing for lead is done every three years. The City's results have consistently been below the required levels. This information is published on the State of Idaho Environmental website.

# **Test Swab Instructions**

The survey kits that were mailed last week included a 3M Lead-Check test swab. This swab can be used to test if the service water line coming into your home contains lead.



Next to the water line coming into your home, Take the test swab and squeeze the body of the swab between the A and B marks. You may have to squeeze harder than first thought.

Once the vial inside the cardboard body breaks. Turn the swab so that the cotton end is downwards so that the yellow test liquid can absorb into the cotton tip. You may have to squeeze the vial a couple of times.



Once the yellow liquid has saturated the cotton end. Place the cotton end on the water pipe. Hold the cotton end onto the pipe for at least 30 seconds.



If the cotton turns red, or pink, that is a positive reaction.

If there is no reaction, you can check the swab to verify that it is working by putting the cotton end onto the confirm test circle. This circle is located on the instruction paper towards the bottom. It is the small glued attachment.
