PLANNING & ZONING POCESSES

The State of Idaho tells all local governments that they shall perform Land Use Planning(1) and defines that purpose (2). Each local government determines the level of complexity of planning and zoning for their jurisdiction.

Some Planning & Zoning things are fairly simple and can be handled administratively. In Ashton, these are called Class I Permits. The city code says "The Administrator shall determine whether the proposed development is in compliance with the comprehensive plan and this title. If the proposed development complies, the application for a permit shall be approved." (3) One single-family home, a single commercial building (even a grain bin), a fence, a garage, a storage shed are all examples of this type of development.

More complex development is handled through a Class II permit, which has to be approved by the governing body, not just by the Administrator. The Class II process starts with a sketch plan review which is simply an opportunity for the commission to be made aware of the proposal and for the developer to be made aware of possible questions and the applicable requirements. Then, the Class II permit has to go through a public hearing. The application is for the high-level concept of the complex development. Neither the city nor the developer will have all of the details ironed out at this point in the process. Complex developments need a more robust process to

manage. The developer will not commit his time, effort, and dollars to the details of the development until he knows the city has approved his zoning permit.

Any construction over 200 sq-ft must have a Building Permit which is separate from a Class I or Class II Zoning permit. The city's Building Inspector reviews the detailed plans to determine compliance with the International Building Code, which has been adopted by the city and the state, and approves this permit application. The Inspector will not begin his review until the P&Z Administrator, or the governing body, has approved the Class I or II zoning permit.

In both cases, the city staff may have many discussions with the property owner and developer to ensure that the requirements are understood and that the plans comply. These interactions may include visiting the property and measuring setbacks and determining the location of infrastructure among other things. The discussions will include the determination of fees and the collection of those moneys before actual development can begin.

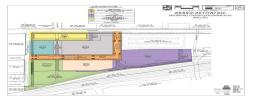
For a Class I permit, the P&Z Administrator and the Building Inspector review the necessary documents and grant the permits where appropriate. The property owner is then able to move forward with construction. For a Class II permit, the P&Z Administrator reviews all of the develop-

er's plans and makes a recommendation to the governing body on whether the plans comply with the requirements. In some cases, the city and the developer will have to sign a development agreement (4) The governing body must approve this agreement, then the city staff manages it through the development process. One of the last steps in the Class II process is the approval of the final plat by the governing body. This does not require another public hearing, but the developer must demonstrate that the final plat complies with the code, the concept that was approved for the Class II permit, and the development agreement.

None of these permits - Class I, Class II, or Building – are ever a rubber stamp telling the property owner he or she can do whatever they want once the permit is approved. Whether the process is simple or complex, the city staff always follows up on compliance and stays in touch throughout the development cycle. The Administrator is also tasked with enforcing the code, often with the help of the Police. Ashton Municipal Code provides for fines to be levied if anyone is in violation of the city's development code.

Traffic Update



Representatives from the Idaho Transportation Department met with city officials to explain that the

signal light at the corner of US-20 and SH- 47 will be installed this year. The bids

were opened last month with the low bid coming in higher than anticipated. The bid cannot be accepted without board approval. If approved and awarded construction should start in either June or July and finish in the fall.

The ITD also explained that there will be paving on SH-47 from the Ashton City limits to Bear Gulch that should start in mid-June. Construction is nev-

er fun to navigate but the outcome should help with safety. The city hopes that everyone will be careful and patient throughout these construction projects.
