Georgia Property Owners Association Act (POAA) - 1994

What is the POAA?

The Georgia Property Owners Association Act (POAA) is a state law adopted in 1994 to give homeowners associations (HOAs) stronger legal powers and clearer rules for managing communities. Communities must "opt in" to benefit from its protections.

Why Was the POAA Created in 1994 by the State of Georgia?

- To define the authority and responsibilities of HOAs.
- To strengthen the ability of HOAs to collect assessments and enforce rules.
- To provide a consistent legal framework for community management.

How Does a Community Opt In?

- Developers can include POAA language when creating the community.
- Existing HOAs can vote to amend their documents to adopt the POAA.

Key Benefits for Communities

- Automatic Statutory Liens: Unpaid assessments automatically become a lien on the property, protecting the Communities financial interests.
- Joint and Several Liability: Both seller and buyer are responsible for unpaid assessments at sale.
- Attorney's Fees: Associations can recover reasonable attorney fees from delinquent owners.
- Perpetual Duration: Community covenants and restrictions never expire, ensuring long-term stability.
- Tenant Compliance: All owners and tenants must follow the association's rules and covenants.
- Amendment Process: Amendments approved by the required majority are enforceable

Adopting the POAA gives your HOA stronger tools to manage finances, enforce rules, and protect property values. It streamlines operations, reduces legal ambiguity, and helps ensure fairness for all members.
