In consideration of renting an inflatable interactive amusement device, I acknowledge that I fully understand the nature of the activities involved in renting an inflatable interactive amusement device from CL MAPLES, LLC dba Busy Bounce.

I understand and acknowledge that the activities involve risks of bodily injury or death, which may be caused by actions or inaction or negligence of my guests, invitees and myself (“participants”). These risks include injury from slipping, falling, crashing or colliding with other participants.

I understand and acknowledge and that there may be other risks either not known or not readily foreseeable at this time.

I fully accept and assume all such risks and all responsibility for losses, costs, and damages that may result from the rental of an inflatable interactive amusement device.

I hereby voluntarily release, discharge, and covenant not to sue CL Maples, LLC, its respective agents, officers, employees, successors and assigns, from all liability, claims, demands, losses, or damages resulting from the rental of an inflatable interactive amusement device.

I further agree that if any participant makes a claim against CL Maples, LLC, its respective agents, officers, employees, successors and assigns, I will indemnify, save and hold harmless CL Maples, LLC, its respective agents, officers, employees, successors and assigns, from any loss, liability, damage, or cost which they may incur as the result of such claim.

I further acknowledge receipt of the directions and safety rules for use of said inflatable interactive amusement device; that I have read and understood the directions and safety rules which I agree to follow and require the participants to follow during the operation and use of the inflatable interactive amusement device.

I further agree to supervise the use of the inflatable interactive amusement device at all times while the device is in possession of Lessee including securing the blowing in a safe locked space

during an over night rental. I further agree that all participants, or their legal guardians if the participant is under the age of eighteen (18), shall be required to sign a Release form acknowledging the risk and accepting responsibility for losses, costs and damages that may result from the use of the inflatable interactive device.
