



## CUSTOMER SERVICE AGREEMENT

A fee of 500.00 will be charged for any equipment that is damaged or not returned within 7 days of termination of contract.

### **2. Compensation:**

The Customer will provide compensation to J & R Solutions for the services rendered by J & R Solutions, as required by this Agreement. Compensation is payable at the signing of this Agreement and monthly thereafter on date specified thru recurring credit card billing to J & R Solutions.

**7. Integration:**

This Agreement contains the entire Agreement and understanding by and between the Customer and the Service Provider and no representations, promises, agreements or understandings, written or oral, not herein contained shall be of any force or effect.

**8. Choice of Law:**

This Agreement and the performance under this Agreement and all suits and special proceedings under this Agreement be construed in accordance with the laws of the State of Indiana.
