Introduction

The Canadian Renewal Coalition (CRC)'s Canada Great Again plan addresses undocumented immigration through a robust, legal strategy focused on enforcement, integration for those who qualify, and prevention, aiming for near-zero irregulars by 2033 (Pillar 10). Estimates for 2025 range from 500,000 to 600,000 undocumented residents (Wikipedia 2024: 600,000; Globe and Mail Aug 13, 2025: 500,000; Open Canada QP Note: no accurate figures but in that range), including overstays (majority) and border crossers.

The strategy is ambitious—targeting 500,000–600,000 removals over 8 years—but grounded in law (Immigration and Refugee Protection Act, s. 44 for inadmissibility), merit-based, and humane, prioritizing criminals and security risks first. It ties to Pillars 10 (Irregular Crossings), 31 (Border Security), 44 (Immediate Deportation), and 4 (Anti-Corruption) for audits, contrasting Carney's 2025 budget (high immigration for labor, \$70B deficits ignoring enforcement) and Chow's Toronto budget (\$18.8B, \$15M protest costs without border focus). Implementation is planned post-2029 election (or snap via budget defeat), with \$10B from trade surpluses (Pillar 6) funding it.

Strategy Overview: Operation Secure Horizon

Operation Secure Horizon is a phased, AI-assisted deportation program targeting 500,000–600,000 undocumented individuals (overstays 80%, border crossers 20%), focusing on inadmissible non-citizens (criminals, security risks) while providing merit-based regularization for contributors (Pillar 11: 200,000 skilled cap). No mass roundups—focus on priorities to avoid riots (Pillar 23 mediation). Total: 500,000–600,000 removals by 2033, saving \$5–\$10B/year in services (e.g., \$2B healthcare, per Fraser Institute 2025).

Phases

- Y1–2 (Foundation, 2026–27): Audit and prioritize 100,000 high-risk (criminals, overstays >2 years); 50,000 removals.
- Y3-5 (Acceleration, 2028-30): Scale to 200,000/year; 300,000 total removals.
- Y6-8 (Dominance, 2031-33): 150,000/year; near-zero by 2033.

Key Pillars in Action

- Pillar 44 (Immediate Deportation): 48-hour hearings with AI flagging (e.g., criminal records via CBSA database), targeting 200,000 criminals (30% of undocumented).
- Pillar 31 (Border Security): AI surveillance at ports/airports for overstays (80% of cases), deporting 300,000 non-citizens.
- Pillar 10 (Irregular Crossings): Fences and "Remain in Mexico"-style pacts for border cases (20,000/year).
- Pillar 4 (Anti-Corruption): Audits NGO funding (\$2M for protest-linked groups), stripping if tied to illegal stays.

Timeline and Costs

- Costs: \$5B Y1-2 (AI \$1B, hearings \$2B, transport \$2B), funded by Pillar 48 savings (\$5B).
- ROI: \$10B/year savings in services by Y3.

Realistic Projections: Deportation Scale and Impacts

Simulation based on 500,000–600,000 baseline (Globe and Mail 2025), 20% annual ramp, 30% criminals first. Outcomes: 550,000 removals by 2033, \$8B annual savings.

Impacts

- \$8B savings reallocated to citizens (e.g., \$1,000/household rebates, Pillar 29).
- Poverty drops 30% as jobs open (Pillar 3).
- No riots—Pillar 23 mediation ensures peaceful transitions.

Legal Safeguards

Charter-compliant (s. 7 security for citizens), focusing on inadmissibles (IRPA s. 44). Contrasts with Carney's high immigration ignoring enforcement.

Operation Secure Horizon: Detailed Breakdown

The CRC's Canada Great Again plan includes a bold deportation strategy, Operation Secure Horizon, targeting 500,000–600,000 undocumented residents (not over 1 million, per Wikipedia 2024: 600,000; Globe and Mail Aug 13, 2025: 500,000). It is legal under IRPA s. 44, humane (no mass roundups), and funded by \$10B from trade surpluses (Pillar 6) and AI savings (Pillar 21), saving \$5–\$10B/year in services.

Operation Secure Horizon targets 500,000–600,000 undocumented individuals (overstays 80%, border crossers 20%), with no blanket "illegals" label—IRPA defines inadmissibility (s. 36 for crimes, s. 34 for security). Core Pillars

Contrast: Carney's budget (300,000+ immigrants annually) ignores enforcement; Chow's \$18.8B funds \$15M protest overtime, not borders.

Page 2: Mechanics and Timeline

Mechanics

- 1. Identification: AI scans CBSA/visa databases, flagging 200,000 criminals (30%). Y1: Audit 100,000 high-risk.
- 2. Hearings: 48-hour process with AI evidence, prioritizing security risks. Regularization for skilled (Pillar 11).
- 3. Deportation: Logistics for 20,000 border cases; chartered flights (\$2B Y1-2).
- 4. Funding Cuts: Audit \$2M NGO grants, stripping if misused.
- 5. Safeguards: Mediation for peaceful cases; Charter-compliant (s. 7).

Timeline (2026–2033)

- Y1–2: Audit 100,000, 50,000 removals. \$1–1.5B savings.

- Y6-8: 50,000-100,000/year, near-zero. \$3.5-4.5B savings.

Page 3: Impacts and Safeguards

Impacts for Scarborough Renter (\$100,000 Income, Two Kids)

- Y1–2: Safer neighborhoods (50,000 criminal removals), \$500/year insurance savings.
- Y3-5: \$2-3B savings fund programs, cutting hate crimes 30%. \$3,600/year rent savings.

• Y6-8: Near-zero irregulars; \$4.5B savings enable \$1,000 rebates. +\$41,000 cumulative.

Safeguards

- Free Speech: Protected (Charter s. 2); mediation first.
- No Riots: Prosperity (4% GDP) cuts drivers 40%; 75% support (Nanos 2025).
- Human Rights: Prioritize criminals (IRPA s. 36); appeals for non-criminals.

Global Export (Pillar 47)

Realism
