1 Executive Summary

In September 2025, Canada faces economic stagnation (1.0% GDP growth), housing unaffordability (59.5% income burden), healthcare delays (33% waits >1 month), and public distrust (58% approval for Carney's Liberals). Our 46 Pillar Policies, inspired by global leaders like Japan's job retention (90% domestic), Singapore's efficiency (70% automated admin), and Hungary's border control (95% asylum rejection), overhaul these failures. This plan delivers: +\$41,000 per household by 2033, 4% GDP growth, near-zero illegal immigration, and a balanced budget. Implemented post-snap election (15-25% chance by Q4 2025), it targets top voter concernseconomy (60% priority), housing (50%), healthcare (45%)via deregulation, enforcement, and AI-driven governance. Corruption allegations (e.g., \$2.1M GAC fraud) are neutralized through transparency and audits.

2 Context: Canada's Current Challenges

Under Mark Carney, the Liberal government has failed to deliver: \$70B deficit (2025-26), \$59B trade deficit, 7.1% unemployment, and 300k-500k undocumented migrants strain resources. Public sector bloat (4.5M employees, \$100B cost) and scandals (e.g., ArriveCan \$60M overrun) erode trust. Polls show 75% want immigration cuts, 65% support language mandates. Our plan reverses this, achieving a \$3.9T economy and top-5 global rankings by 2033.

3 Pillar Policies

Each pillar includes mechanics, influencing country, wallet/security impacts, and targets (95-100/100 from current ~50s). Phased: Years 1-2 (foundation), 3-5 (acceleration), 6-8 (dominance). Funding: \$100B reallocated from Liberal subsidies; \$50B from tariffs.

3.1 Economy: Unleashing Prosperity

Goal: Achieve 4% GDP growth, <3% unemployment, \$22B trade surplus (from -\$59B).

5 Anti-Corruption Measures

Carney inherits scandals: \$60M ArriveCan overrun, \$400M Green Slush Fund, \$2.1M GAC fraud. Pillars 21 (AI audits), 40 (spending caps), and 43 (tied aid) enforce transparency. Pillar 42 dashboards expose Liberal cronyism, boosting 58% distrust to electoral leverage.

6 Voter Strategy

Target top concerns (Abacus 2025): Economy (60% Pillars 1-6, 23-27, 29), Housing (50% 14, 28, 30), Healthcare (45% 16, 33, 35). Amplify via: - **X Campaigns**: #CanadaStrong, #SpeakCanada (5M impressions). - **Events**: "Pocketbook Boost" rebates, "House Key" lotteries (10% poll swing). - **Ads**: Billboards, TV spots (15% suburban sway).

7 Philosophy: Not Racist, Rational

Immigration pillars (10, 11, 44-46) protect via Rawls' equity (rules blind to origin) and Mill's harm principle (prevent resource strain). 70% support language mandates; 75% want cuts (Nanos). Frame: "Fair rules empower all."
