# No Confidence in Carney: Unfulfilled Promises and a 48-Pillar Plan for Canada's Future

## 1 Executive Summary

Fellow Canadians, as Justin Doyle of the Canadian Renewal Coalition, I call for a no-confidence vote against Prime Minister Mark Carney and his Liberal minority government. Elected on April 28, 2025, with 150-160 seats and NDP support, Carney's government has failed to deliver on critical promises, leaving Canada at a D+ (47.5/100) across key metrics: 1.0% GDP growth (Bank of Canada), 59.5% housing burden (RBC Economics), 33% healthcare waits over one month (OECD), and a \$70B deficit (Finance Canada). Public approval stands at 58%, down from 64% (Abacus Data, September 2025), with 54% disapproving of economic handling (Liaison Strategies, August 2025). Of 20 key campaign promises, none are fully delivered, 12 are partial or in progress, and 8 are stalled (Brock Press, September 15, 2025). With Parliament resuming in October, a no-confidence motionsupported by Conservatives, Bloc Québécois, and potential NDP defectorscould trigger a snap election by November, mirroring Joe Clark's 1979 fall after nine months. Our 48 Pillar Policies offer a path to C+ (66-69/100) by 2029 and A+ (90-100/100) by 2033, addressing every failure with simple, results-driven solutions: \$41,000/household gain, 2 million homes, 100,000 doctors, and 0.99 CAD/L gas. This document lists Carney's promises, their status, and our fixes, grounded in data from Statistics Canada, CMHC, and public polls.

# 2 Current State: D+ (47.5/100)

Canadas performance under Carney is graded D+ (47.5/100), averaged from six areas: Economy (55/100), Housing (40/100), Healthcare (35/100), Safety (65/100), Immigration/Integration (50/100), and Efficiency/Corruption (40/100). Key issues include sluggish 1.0% GDP growth (below G7 1.4%, Bank of Canada), 7.1% unemployment (StatsCan August 2025), 59.5% housing burden (RBC), and \$400M in

opaque anti-hate funding (CIPS, 2025). Carneys minority government, reliant on NDP support, faces 58% approval but 54% cost-of-living disapproval, justifying a no-confidence vote.

# 3 Carneys 20 Campaign Promises: Status and Failures

Below are 20 key promises from Carneys 2025 campaign (Liberal Party platform, CTV Promise Tracker, Global News, Politico), with fulfillment status as of September 2025, sourced from Brock Press, National Post, Hill Times, and PMO releases. Status is factual: Delivered, Partial/In Progress, or Unfulfilled/Stalled, with specific reasons for deductions.

### 4 Summary of Carneys Failures

Of 20 promises, none are fully delivered, 12 are partial/in progress, and 8 are unfulfilled/stalled. Brock Press (September 15, 2025) notes "uneven translation of campaign pledges," with economy (1.0% GDP), housing (100k vs. 500k units), and deficit (\$70B) as key failures. Public distrust (58% approval, 54% cost-of-living disapproval, Abacus/Liaison) and NDP fragility (150-160 seats) justify a no-confidence motion. With 20 Liberal defectors or Bloc/NDP support, a snap election by November 2025 is feasible, per Joe Clarks 1979 precedent.

## 5 Our 48 Pillar Fixes: Simple Catchphrases for a Great Canada

Carneys failures leave Canada at D+ (47.5/100). Our 48 Pillar Policies deliver C+ (66-69/100) by 2029 and A+ (90-100/100) by 2033 with clear, results-driven catchphrases. Funding: \$100B reallocated from waste (e.g., \$6.4B from anti-hate envelope, CBC, Pillar 48) and \$50B tariffs (Pillar 6). Outcomes: \$41,000/household gain, 2M homes, 100,000 doctors, 0.99 CAD/L gas, 200,000+ jobs.
