Message from the Board

Dear Friends,

Last year was a unique year in all our lives. The education challenges faced by families and children due to the coronavirus pandemic was, and continues to be, enormous. Some children are safer, and can thrive, in a remote learning environment. Others have little or no ability to access education without in-person supports. Remote isolation causes additional health and safety concerns. School districts across Nebraska are reacting in widely different manners to the pandemic. Some declined to provide any education services for several months; some have moved to completely synchronous “live remote” education; some are relying on part-time school and part-time packets. ERC has been called upon to help sort through this massive disruption and find a way forward, unique to each family and child. At this writing, we are working with many children to obtain recovery services.

Last March, ERC’s first undertaking was to become a primary source for family oriented COVID information, posting rights, responsibilities, and videos on the web and working directly with the Nebraska Department of Education to ensure families interests were represented in the guidance and requirements issued to school districts. Next, ERC pivoted to addressing the lack of instruction being provided to juveniles. When children were reported as truant, we intervened when lack of attendance was due to lack of access to technology, missing skills, or simply erroneous data. Working with the Douglas County Juvenile Court, we helped develop a process for the appointment of limited representation education counsel for students where a need is indicated.

ERC has increased its interactive programing for families, communities, and Nebraska attorneys, undertaking regular webinars and providing regular direct continuing legal education for legal counsel. To meet the needs of families, we have increased our staffing and doubled our partnership with outside counsel assisting children.

In 2021, the work of ERC remains critical, and we are excited to see new opportunities emerge as we partner more deeply with other community organizations and nonprofits. By joining with others to develop and implement solutions differently, we will create the systemic change necessary to ensure that all children, regardless of socioeconomics, color or ability can stay in school and thrive.

The more we invest in equity for all children, the stronger we are as a state and nation. Thank you for joining us in making their promise a reality.

Education Rights Counsel provides education, research and representation to families, educators, stakeholders, judges and attorneys. Our vision is educational equity for every child. Our mission is to amplify the voices of our most vulnerable children by removing legal barriers so that all children stay in school and thrive.

Access to public education is a legal right. The laws governing education are nuanced, layered and complex. Families without resources to navigate the system experience significant inequities, including denial of services, removal from school, and unnecessary referrals to the juvenile justice system.

Education Rights Counsel is generating systemic change in Nebraska by equalizing access to advocacy for under-resourced families, with a focus on special education support and due process. We partner with multiple individuals and organizations across the state to build understanding through education and engagement.

Individual Representation & Advocacy

Providing advocacy and legal representation at no cost in limited engagements for low-income public school families needing help with special education and student discipline.

BUILDING AN ARMY OF ADVOCATES

Nebraska has 26,000 students with a verified disability living in poverty. Many need help obtaining appropriate services and working through discipline referrals. Education Rights Counsel expands our impact by:



- Working to educate Nebraska's legal community to increase knowledge related to education law;
- Representing Individuals to ensure their educational rights are protected
- Serving as a reliable sounding board for legal counsel and community advocates across Nebraska;
- Collaborating with advocacy organizations to provide comprehensive education law guidance in intersecting fields;
- Developing strong self-advocates by providing tools and supports to aid advocacy.

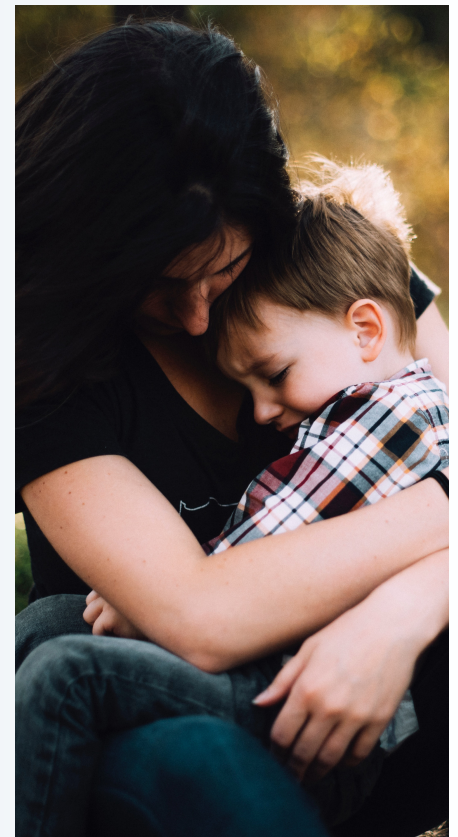
AMY & MAX

Amy first came to ERC two years ago, struggling on behalf of her kindergarten son, who had no IEP.

"I felt lost, confused, hopeless. I didn't know how to help my child. I felt like the school system was against us and not helping us as far as what Max really needed, because he wasn't a bad kid, he just needed help in different areas... For a couple of weeks, they were telling me that they were putting him in a safe room when he would have these outbursts and temper tantrums. I was told that he needed to start his day off in that room and work his way out, so I offered to take him back there. He screamed and kicked and begged me the entire time to not take him to that room... it was a completely padded room with a small window and a door. When I sat in that room with him, I couldn't leave him in there...I ran out of the school with him and we sat outside and cried."

ERC worked with Amy and Max, putting in place a solid IEP. Today Max is very successful in his regular classroom. Importantly, Amy has become a solid parent advocate.

"I'm pretty confident going into these things now. I know that, as a parent, we're not helpless, there's things that we have control over. I know sometimes we feel overpowered by the school system, and I don't feel that way anymore."



MAKING A DIFFERENCE TOGETHER

Board President Debora Wisneski and Executive Director Lauren Micek Vargas were interviewed on UNO TV via Zoom to discuss the rights of children in education.

Lauren was featured in One Day Magazine as one of four women who are **Lawyering For Good**, highlighting the work of Education Rights Counsel.

Board Member George Achola provided an editorial in the Omaha World Herald concerning the harms and disparate impact this bill would have had on children of color. ERC is grateful this bill did not pass.

"We've grown in terms of our clients and advocacy. We've been able to train an army of advocates to not only make sure there is legal access to attorneys in the school system, but that we are breaking down systemic racism for individuals with disabilities and kids of color. That's influencing legislation, training attorneys to take cases for us so more attorneys are doing this type of work, and challenging what's happening for our kids."

The Lincoln Journal Star reported on ERC's opposition to a bill introduced in the Nebraska Legislature permitting the physical restraint of students and preventing legal claims for harm arising from that restraint.

In a letter covered by the Omaha World Herald in July, Education Rights Counsel joined other non-profit organizations seeking increased funding for counseling and other mental health services.

Lauren was invited to address the Nebraska State Bar Association's virtual Pro Bono Summit, discussing the work of Education Rights Counsel, the importance of pro bono advocacy, and introducing the keynote speaker.

IMPACT

DIRECT REPRESENTATION AND CONSULTATION



ERC provides consultation with families, advocates and stakeholders across the state, working to ensure that parents have needed legal support and are equipped to advocate on their child's behalf. In 2020 we served 18 families directly and consulted with over 60 individuals to help them understand their educational rights.

LIMITED REPRESENTATION JUVENILE COURTS



ERC helped establish a process for the appointment of education counsel in cases involving delinquency, status offenses and neglect cases and subsequent to implementation, individuals affiliated with ERC served as limited representation education counsel in 13 cases.

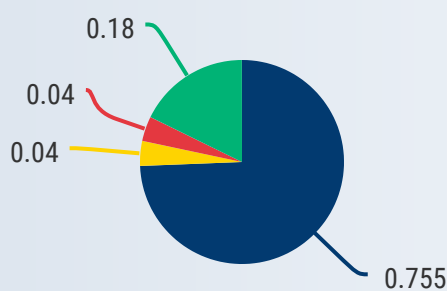
PROFESSIONALS TRAINED

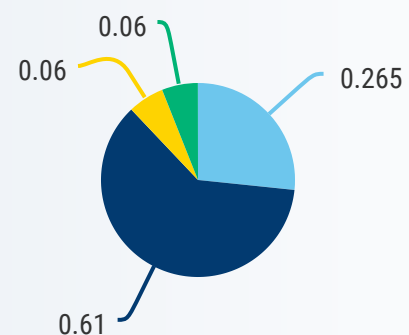
